Subject (title): Approving Amendments to CLUSITC Chapter 5-4 (Tobacco) on an

**Emergency Basis** 

WHEREAS: The Tribes enacted the Tobacco Ordinance by Resolution No. 01-

098 on December 17, 2001, and it was most recently amended on

August 10, 2014;

WHEREAS: The Tribes' Tobacco Ordinance is codified at CLUSITC Chapter 5-4

(Tobacco).

WHEREAS: Additional amendments to CLUSITC Chapter 5-4 (Tobacco) are

required as a condition to entering into a Tobacco Products Tax Refund Agreement between the Tribes and the State of Oregon;

WHEREAS: The required amendments clarify the obligations imposed on persons

and entities that distribute or sell tobacco on Tribal land;

WHEREAS: The Tribes and the State or Oregon wish to execute the Tobacco

Products Tax Refund Agreement on November 17, 2014:

WHEREAS: It is in the best interest of the Tribes to enact Ordinance 034E

amending CLUSITC Chapter 5-4 (Tobacco) on an emergency basis pursuant to CLUSITC 1-7-2(e), waiving the posting and twenty-eight (28) day comment period, to allow for execution of the Tobacco

Products Tax Refund Agreement on November 17, 2014.

**THEREFORE BE IT RESOLVED,** that the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians' Tribal Council hereby approves adoption of Ordinance 034E amending CLUSITC Chapter 5-4 (Tobacco) on an emergency basis pursuant to CLUSITC 1-7-2(e), and hereby waives the posting and twenty-eight (28) day comment period.
