# Confederated Tribes CLUSI Acquire Additional Land at Fossil Point

On October 15, 2015 the Confederated Tribes took ownership of another tract of land in our Coos Bay Fossil Point Complex. Our latest acquisition consists of approximately one-half acre of upland, and approximately seven and one-half acres of tideland. This important land acquisition brings another traditional cultural property under Tribal stewardship, and increases the Confederated Tribes' total land base to more than 542 acres!

South Coast Land Conservancy offered to donate this valuable property to the Confederated Tribes in 2013 to ensure its permanent protection, and the Tribal Council passed a resolution in June of that year authorizing the Tribal Administrator to negotiate and complete this land acquisition.

Tribal realty and natural resources staff have been working hard ever since to complete all the technical and legal due diligence necessary to ensure this land can help support the strategic goals of the Confederated Tribes, that the tract comes with no significant title or environmental problems, and that the property is suitable for conveyance to the United States in Trust in accordance with the Tribal Council's wishes.

In 2002 Fossil Point Unit 1 was acquired in trust for the Confederated Tribes by the United States Government under authority of the Indian Reorganization Act of 1934. The Tribal Council has directed that Fossil Point Units 2 and 3 also be offered for conveyance to the United States in Trust for the Confederated Tribes. We expect the Fee-to-Trust ownership transfer process to take approximately 18-24 months under

current agency regulations and guidelines.

Fossil Point Units 1 and 2 are already open to public use, as is the tideland portion of Unit 3 which is accessible from the Cape Arago Highway pullout. In the future the Confederated Tribes hope to improve foot access for suitable use of the upland portion of Unit 3 as well. However, due to the sensitive habitat and highly unstable bluffs, access to the tract's high ground is currently restricted to Tribal staff and authorized Members only.

# **PREVENTION ACTIVITIES Drum Making 2015**

We blessed the Tribal Hall by burning some cedar. Clifford Latta from Grey Wolf Drums brought in the drum kits and hides. We did a quick opening and set up to get started. Cliff talked about the drums and how we were going to put them together. We placed the frames on the elk hide drum heads, then tied the center circle of rawhide on the frame, and laced the raw elk hides around the handmade frames. We centered everything and the tightening began. The lacing and tightening is what takes the most time; if you pull too hard or if there is a flaw in the nide, the center ring can break. That only happened on a few drums this year. It takes patience and perseverance to recover

Now available at the Tribal Administration Building, Florence and Springfield Outreach offices.



# What is a Tribal Committee?

<u>Chapter 7-5 GENERAL COMMITTEE CODE</u> 7-5-1 General Policy; Committees are established to assist the Tribal Council in carrying out its responsibilities, to provide quality services to the Tribal membership and to develop, maintain and protect the assets and interests of the Tribes.

Tribal Committee appointments are made by Tribal Council and are for a four (4) year term. Tribal Code allows for you to be on no more than three (3) committees at a time and you may only serve two (2) terms, unless special consideration is necessary. Currently we have at least one position available in each committee due to vacancies and term expiration on 12-31-2015. Tribal Committees cover several areas of the Tribe and work with various departments. Below is a list of Committees.

Culture Committee, Budget Committee, Education Committee, Elders Committee, Enrollment Committee, Housing Committee, Investment Committee, Health Committee & Election Board

How to become a member? You must be a CTCLUSI enrolled Tribal member. A Letter of Interest Form must be completed and submitted by December 15<sup>th</sup> for Council considerations on December 30<sup>c</sup> 2015. Letters of Interest are only kept on file for one year. Forms can be found on the Tribes website: www.ctclusi.org or requested through any Tribal Government Office.

In accordance with CLUSITC 7-1-37(a), Tribal Members shall have the right to protest the recommendation of the Committee approving an application and must file a written, signed protest with the Committee stating their reasons for believing that an Applicant(s) is not entitled to enrollment. The protest must be filed with the Committee within twenty-eight (28) days after notice of the proposed enrollment is posted as described in CLUSITC 7-1-36(i).

## **CONTRACT HEALTH UPDATE: OUR NAME IS CHANGING**

In January 2014, the Consolidated Appropriation Act of 2014 resource cards. If you have separate plans for dental, vision, renamed the IHS Contract Health Services program to the etc., don't forget to include these cards as well. Purchased/Referred Care (PRC) program. Tribes have been working since then on renaming the program at the Tribal level to be consistent with the federal program. Therefore, effective January 1, 2016, the Contract Health Services program will become the Purchased/Referred Care program. We are currently working on changing the name on all printed materials. We will have new program handbooks and wallet cards available beginning December 12, 2015 at the Tribal Christmas Party. Aside from the name change, all of the policies and practices remain the same.

Renewal forms for 2016 were mailed in late October to all Tribal members currently living in the Oregon five-county service delivery area of Coos, Curry, Douglas, Lane and Lincoln counties. The Deadline for submitting completed forms was November 18th. If you have not returned your form yet, please get them to us no later than December 5, 2015. Please remember to include copies of the front and back of all insurance/alternate

Remember, you are required by federal regulation (42 CFR, Chapter 1, Subpart 136.23 F) to apply for an alternate resource if there is reason to believe you may be eligible. Furthermore, if you do have an alternate resource you are required to use it for your care before using PRC funds. Failure to apply for and/or use an alternate resource you are eligible for will result in denial of PRC payment.

Vision benefits are changing beginning in January 2016. We are increasing the amount for vision (exams, glasses and contact lenses) to \$500 each year. Disease-related vision treatment, including cataract surgery and glaucoma treatment, is covered under the medical benefit. Also new in 2016, there will no longer be an age limit for vision. Everyone will be able to get an exam and glasses/contacts each year, if needed, regardless of age. All other benefits remain the same in 2016.



This year the Tribes' Department of Natural Resources (DNR) had the privilege of hosting the Oregon Tribal Environmental Forum (OTEF). Held in Florence, Tribal, state and federal representatives, traveled from all over Oregon, Washington and Idaho to attend the two day event. OTEF was started in 1999-2000 by Oregon Tribes, to encourage discussion of Tribal environmental issues and concerns unique to Oregon. OTEF continues to focus on developing collaborative efforts and resources to address Tribal issues with a collective knowledge and experience approach. Day 1 of the forum was presentations from DNR staff about the Tribes projects and programs, followed by thirteen presenters covering a multitude of topics; emergency preparedness planning and disaster resilience (earthquake/tsunami), EPA Water Quality Standards rule-making, climate change in Indian Country, Green Funding Opportunities - Grants, West

# The Law Way versus the Peace Way

Tribal Court hosted a Peacegiving Training in October with two tribal judges/trainers, Dave Raasch, Mohican Tribe, and recently retired trainer from Fox Valley Technical Institute, and Ernie St. Germaine, Lac du Flambeau Tribe, retired but still on the faculty at the National Judicial College at the University of Nevada-Reno. All attendees were very happy with the training which included a day of tradition and history on a variety of subjects including Bringing Peace Back to the Community through Tradition, Ceremonies and Language, and actual hands-on circle training.

One of the many things of interest was when Ernie demonstrated how important it was for people to communicate tradition verbally among family members. He had volunteers line up as a sample family to illustrate seven generations. He asked participants if they knew the names, birthdates, favorite songs and favorite dances of their parents. As the participants nodded their assent, he then asked if they knew that information about their grandparents, then their great-grandparents. As fewer people could say yes, it showed how important is to keep not only a written history but an oral history because it could signify a loss of family tradition, knowledge and stories. Ernie said that he used to tell his family story so much that one day one of his grandchildren interrupted and began telling the story himself, much to grandpa's pleasure.

Also included in the training were circle scenarios in which all participants were included. One demonstration was a traditional circle where one person has a talking stick and the others have to listen to the

speaker to discuss an important Tribal issue.

Another circle demonstration was a scenario where there was a divorcing couple arguing about the return of an item. In that case, it allowed the speaker to ask questions of the couple about why they believed the item should belong to them, or its significance to them. Seeing different ways to conduct a circle was beneficial to the participants because every issue can be dissimilar and may need to be treated in a unique way.

A final circle was conducted regarding a youth with issues and how the family and community members could help the youth on the right path. When it came out that the youth liked to dance, the whole circle participated.

In addition, Tribal Court co-sponsored the Tribal Family Dinner with the Family Services Department so that Tribal Members had the opportunity to meet the visiting Judges and learn a little about them. We were very happy to have the judges travel the distance to share their knowledge.

Tribal Court is planning shorter trainings after the first of the year at the request of the Peacegivers.

To qualify now for heating assistance through LIHEAP, families must reside in the five county service area of Coos, Curry, Lincoln, Douglas, and Lane, and fall into 60% of the Estimated Oregon State Median Income as listed below. To qualify in <u>December 2015</u> or this Federal Program, your yearly income needs to be at or below the following:



# **Beyond the Biggest Loser**

Our Health and Human Services Department (HHSD) would like to implement a wellness goals program. According to the Native Wellness Institute (2002), at the heart of the term "Wellness" lies personal responsibility. As a wellness program, participants will be setting individual goals to become more balanced physically, mentally, emotionally, and/or spiritually. Our goals program will be titled:

ilwechos (Heart, Mind, Opinion, Soul) A culture of Wellness: Restoring Balance & Tribal Identity

At the root of this program, our foundation is built upon the sacred circle. The great circle of life is aligned with the teachings of the medicine wheel, based upon balancing: mental, spiritual, physical, and emotional aspects of life.

The medicine wheel is also a wheel of protection it "allows us to gather surrounding energies into a focal point and to commune with spirit, self, and nature" (Laframboise & Sherbina, 2008). Setting short and long term goals aid in identifying our individual areas of growth, while supporting the overall intention of balance. Both personalized daily goals and long term goals will be identified, short term measurable goals may include:

- Complete \_\_\_\_\_ minutes of: meditation, stretching, walking, yoga, pilates, exercise, journaling, and/or other self-care activities daily.
- Increasing water intake, whole foods (less processed), eating breakfast daily, or focusing on healthy portions.
- Before and after lab improvement (HgA1c, Lipid Panel, Microalbumin), reducing blood pressure consistently for 3-6 months.

Long term goals are supported by our daily thinking and habits. Aligned with the healing of the canoe curriculum, every paddle stroke counts. It begins with daily awareness, positive thoughts, choices, and healthy self-care. We invite you to come be a part of our culture of wellness. Find out how to restore balance into your life, through individual goal setting and cultural identity. Our goals program is set to launch near Winter Solstice, goal setting forms will be available December 12<sup>th</sup> at our Holiday Celebration dinner. # **Plan for Power Outages**

If the power does go out in your neighborhood, stay calm. Call your power company first instead of calling 911. They are for emergencies only. Don't open the refrigerator for long periods of time or if you don't have to. Turn off all the light switches and unplug all electronic devices, that way bulbs and appliances don't burn out. To make waiting for power fun, bring out some board games or make up some games to play. If the power outage lasts longer than a day then every family should have a bag ready with supplies in it. What should be included in that bag are the following items:

- Flashlight
- Extra batteries
- Matches
- Toilet paper
- Non-perishable Food items (ex. Granola bars, water, etc.)
- A phone
- First aid kit
- A crank radio

# Yachats to Hold 6th Annual New Year's Day Peace Hike

Start the New Year off on the right foot! Join the Yachats Trails Committee and fellow trekkers for the 6th Annual New Year's Day Peace Hike to the Amanda statue south of town. Participants should meet in the Yachats Commons' main events room (441 N. Hwy 101, Yachats) at 10:00 a.m. on Thursday, January 1st.

At 10:00 a.m., Yachats Mayor Ron Brean will introduce Doc Slyter, Elder, Tribal Flutist and Tribal Council member for the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians. Doc will tell the story of Amanda, a blind woman forced to leave her young daughter and march barefoot through rocky terrain to the Alsea Sub-agency internment camp in Yachats in 1864. It is a story of tragedy and extreme injustice, but also of how acknowledging truth and injustice can help two cultures find common ground for healing.

It is through the Tribes and community's endeavors with the Amanda Trail that many have become more aware of the great need to acknowledge the wrongs of the past; and to be more conscious of the need to treat people of all cultures throughout the world with honor, dignity and respect.

Participants will then depart on an invigorating 6-mile round trip hike that will take them along the south 804 Trail, across the Yachats River Bridge, along Yachats Ocean Road, to the Amanda Trail and the final destination -- the Amanda Grotto and statue. At the grotto the group will have the opportunity to contemplate and offer blessings for peace in the New

Year. Native American flute playing will be provided by Doc Slyter and Mary Beth Nickel. Hikers may then walk or shuttle back to the Commons for more camaraderie, a potluck refreshments, hear music, view displays of participating organizations, to collect their commemorative Peace Hike pin. The image for the 2016 pin was created by the Siuslaw National Forest Artist-in-Residence,

Margie Lopez Reid, and the painting was donated to the City of Yachats by Ben and Kathee Christensen.

Two beautiful oils will be auctioned off. One is by painter Margie Lopez Reid depicting the 2015 Peace Hike to benefit the Yachats Trails Committee. The second is by the 2015 Siuslaw National Forest Artist-in-Residence, Collen Caubin, that will benefit the 2016 Artist-in-Residence Program.

Participants should dress for changeable weather, wear sturdy shoes and bring walking sticks if they have them. The walk from the Commons to the Amanda Statue is approximately 6 miles round trip, and is on both paved road and narrow dirt trail surfaces with some stairs and moderate inclines.

In the event of heavy rain or wind the hiking portion of this event will be cancelled, and

the peace ceremony will take place in the covered shelter behind the Yachats Commons.

#### About the Amanda Trail


The Amanda Trail was

completed and dedicated in July 2009. A 25-year endeavor, the Trail has helped reveal the truth about the treatment suffered by the Alsea, Siuslaw, Coos and Lower Umpqua People during their incarceration at the Alsea Sub-agency prison camp from 1859 to 1875. Since the Trail's dedication. the Confederated Tribes of the Coos, Lower Umpqua and Siuslaw Indians (CTCLUSI) and members of other Tribes have become an important part of the Yachats community. CTCLUSI also provided financial aide and skilled labor toward the replacement of the pedestrian bridge along the Amanda Trail. An article co-authored by Joanne Kittel and Suzanne Curtis about the First Nations' history including the prison camp years can be can be purchased at Mari's Books in Yachats. Additionally, in November 2011, Tribal historian Don Whereat and Yachats citizens published a compilation of Mr. Whereat's articles on tribal history and culture to promote greater awareness and understanding.
