To date, we have mailed out over 300 kits total and have received much appreciation from Tribal Members who have received them.



7-3-23 Candidate Eligibility

According to the Tribal Constitution (Article VIII, Section 4(a)), in order to be eligible for election to a Tribal Council position, candidates shall meet the following qualifications:

- (a) Be a duly enrolled member of the Confederated Tribes;
- (b) Be at least twenty-one (21) years of age; and
- (c) Never have been previously removed from office for good cause after the date the Tribal Constitution was ratified. (May 23, 1987).

7-3-24 Statements of Candidacy

(1) Candidates shall file Statements of Candidacy no later than thirty (30) days before the scheduled date of the election. CLUSI Const. Art. VIII, Section 4(c).

Each candidate shall indicate the position for which he or she is filing. No shuffling of positions will be allowed. You may submit to any CTCLUSI Government Office.

Deadline to File - Friday March 11, 2022 by 5:00pm

POSITION STATEMENT REQUIREMENTS Each candidate will be given the opportunity to present a position statement for inclusion in the Tribal Newsletter if submitted by the Newsletter deadline. Position statements shall not be longer than one (1) sheet of 8-1/2" by 11" paper printed on both sides, capable of being copied on a black and white copier (can be color). Position statements shall be published in the February, March or April issue, depending upon when the candidate filed and the candidate's preference once submitted to Election Clerk. Once a Statement of Candidacy is submitted see Newsletter deadlines below.

> **Newsletter Deadline for Position Statement Publication:** Friday, January 14, 2022 for February 2022 Newsletter Friday, February 11, 2022 for March 2022 Newsletter Tuesday, March 15, 2022 for April 2022 Newsletter

You can only be in one publication; any other political mailings, once reviewed by the Election Board will be at the candidate's expense.

We are currently seeking new members for Tribal Committees. <u>Chapter 7-5 GENERAL</u> <u>COMMITTEE CODE 7-5-1; General Policy</u>; Committees are established to assist the Tribal Council in carrying out its responsibilities, to provide quality services to the Tribal membership and to develop, maintain and protect the assets and interests of the Tribes.

Tribal Committee appointments are made by Tribal Council and are for a four (4) year term. Tribal Code allows for you to be on no more than three (3) committees at a time and you may only server two (2) terms, unless special consideration is necessary.

Currently, we will have at least one possible position available in each committee due to vacancies and term expiration on 12-31-2021. Tribal Committees cover several areas of the Tribe and work with various departments. Below is a list of Committees you may be interested in becoming a member of:

Budget Committee Enrollment Committee Health Committee Education Committee
Housing Committee
Election Board

Qualifications of membership? Chapter 7-5-5(d) (1) Is an enrolled Tribal member; (2) Demonstrates skills and ability relevant to the committee's work; (3) Possesses relevant education, training, or work experience; (4) Represents a particular constituency of the Tribes; (5) Brings perspective or experience that will contribute to the work of the committee; (6) Demonstrates commitment to the committee's work through regular attendance at meetings and active participation; and (7) If a background check is required under CLUSITC 9-6-7, is determined to be suitable for the position using the standards in CLUSITC 9-6-6.

<u>Letters of Interest are only kept on file for one year.</u>

The Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians' Gaming Commission is established pursuant to CLUSITC 5-2-7. The purpose of the Gaming Commission is to regulate Class II and Class III gaming on the Confederated Tribes' Indian Land. The Commission consists of five (5) members appointed by a majority vote of the Tribal Council.

The Gaming Commission has a term ending and are seeking interested parties. The term of this position is three years. Interested parties shall file a statement with the Commission reflecting their interest in serving as a Commission member.

Qualifications for the Posted Vacancy:

 $Commissioners\ must\ meet\ the\ following\ minimum\ eligibility\ requirements\ (CLUSITC\ 5-2-7(d):$

- (1) Must be at least twenty-one (21) years of age;
- (2) Must successfully complete a background investigation, as set forth in CLUSITC 5-2-15;
- (3) No member of Tribal Council may serve as a Commissioner; and
- (4) No employee of a Gaming Operation may serve as a Commissioner.

Each applicant for Commission membership shall be subject to a background investigation (CLUSITC 5-2-13) and drug testing (CLUSITC 5-2-21).

Department of Natural Resources Adds Restoration and Wetlands Project Manager to the Team

My name is Kyle Terry and I am pleased to be the new *Restoration* and *Wetlands Project Manager* in the Department of Natural Resources and Culture. My experience fits this position very well and I'm happy to have the opportunity to contribute here and learn from this community. My first few weeks flew by but I already met several CTCLUSI staff and look forward to meeting more soon.

Here is a bit about my background for those I haven't met yet.

My family lived in Winchester Bay when I was young then moved to the Florence area where I graduated high school. While living near Florence I started to work as a carpenter and I still spend a lot of my free time in my small workshop. Right now, I am chipping away at a Port Orford cedar surfboard when I'm not helping friends with their projects.

I moved away from Florence and went to college when I was 26. I studied rivers and landforms while living in Eugene and earned a degree in geography with a minor in geology. After that, I spent a summer working on the Mid-Fork John Day River at the Confederated Tribes of Warm Springs Oxbow Conservation Area. We measured the effects that the Tribe's restoration projects had on the various river processes like gravel deposition, side channel development, and scouring of new pools.

After being in the John Day area, I worked in Humboldt County for two years mostly surveying steep, streamside landslides (covered in poison oak!) for Green Diamond Resources Company.



I worked as a geology tech and forestry tech while in California but I soon felt the pull back to Oregon and moved back and started working at the Siuslaw Watershed Council as the Restoration Crew Leader. A year later I became the Programs Manager at the Council, managing four core programs annually and ecological restoration various projects. I was fortunate to work with the Council at a time when they were a key partner in a Forest Service project on Fivemile Creek pioneering a holistic approach that proved successful and is now used more broadly. I look forward to working with some of these same partners and applying similar techniques to CTCLUSI projects.

Look What We Can Do! CTCLUSI Undergoes Massive Upgrades to Environmental Testing Laboratory

Department's Environmental

Testing Laboratory, which

happily was granted!

Since 2016, CTCLUSI's environmental laboratory has been dedicated to monitoring water quality parameters, such as pH, temperature, salinity, conductivity, turbidity, dissolved oxygen, and bacteria. Staff also use the lab to process field samples for contract analyses, such as nutrients and

macroinvertebrates.

More recently in 2019, the Culture and Natural Resources Department acquired a gas chromatograph mass spectrometer (GCMS) to monitor pesticides, herbicides, volatile organic compounds, and numerous other

contaminants of concern. The COVID pandemic delayed formal training on the instrument, but staff have still been able to analyze water samples for contaminants, and are slated to begin testing fish tissues and vegetation.

But staff have for years identified the need to grow the laboratory to include more analytical capabilities based on environmental and health concerns. This includes toxic algae in recreational waters, sewage releases from residential septic or ineffective wastewater treatment, and legacy pollutants from either the manufacture or degradation of products like rubber, petroleum, paper, plastics, fertilizers, and pesticides. With the onslaught of the COVID pandemic, the Department especially wanted the ability to detect the SARS-CoV-2 virus in traditional waters.

In August and September 2021, the Department of Culture and Natural Resources asked Tribal Council for funding support analytical improvements the Department's Environmental Testing Laboratory, which happily was granted! Environmental staff are currently coordinating the installation and training for a variety of instruments, listed below.

FlowCam

This instrument images particulates in a filtered water sample, then uses software to identify the images for plant or biological substances, and possibly even microplastics. Knowing what kinds of particulates are in a waterbody will help Departmental staff make more informed decisions relating to water quality management going forward. Departmental staff also hope to identify algae species so that we may know what specific toxins might be present, as well as for screening wastewater treatment plant (WWTP) filtration efficacy. We have a scientist with South Slough Estuarine Research Reserve poised to help us start routine analysis.

Liquid chromatograph Mass Spectrometer (LCMS)

This instrument not only complements our GCMS to analyze for pollutants, but for greatly expands the range of what we can find. This instrument should be able to scan samples for their "ion" components

> so that we can see everything we can possibly want to see in a sample. We can process any type environmental of including sample, water, tissues, vegetation, sediment. Currently, Departmental staff are trying to target per- and

polyfluoroalkyl substances (PFAS; used in flame retardants) at Coos Head and algal/shellfish toxins (such as at Tenmile Lakes) for monthly analysis. But there are a lot of other proposed projects we are strategizing. For instance, sea lion whiskers were recently found to contain contaminants from car tire rubber. Departmental staff are seeking to develop a project to analyze contaminants in sea lion blubber and identify the possible health risks associated with its future reintroduction into Tribal Member's diets.

Quantitative Real-Time Polymerase Chain Reaction (qPCR)

This instrument will be used for "targeted" screening for specific DNA or RNA of anything we wish to look for. Staff hope to implement methods for understanding sources of consistently high bacteria inputs in local waters, such as might be coming from residential septic or sewage releases. We also hope to test out wastewater treatment and filtration efficacy in Coos Bay, Lakeside, and Florence. But in order to process samples to avoid DNA cross contamination, staff are coordinating a small structural expansion to accommodate a "clean room", where staff must wear full protective gear, and all equipment and supplies will be sterilized in bleach and under ultraviolet (UV) light.

Wastewater Treatment Plant (WWTP) assistance:

In support of the Tribe's ongoing desire self-governance, the department wishes to support compliance monitoring for the Tribe's WWTP at the Florence Three Rivers Casino. For this purpose, staff have accumulated various specialty equipment and supplies to begin and continue in-house testing to support the Tribe's WWTP operations.

Portable X-Ray Fluorescence Spectrometer (pXRF):

With this machine, Departmental staff can non-destructively conduct surface analyses of heavy metals, such as arsenic, mercury, and lead at the parts per million (ppm) level. Data produced will help staff to understand the potential for acute and chronic health effects derived from repatriated cultural materials that may have been treated with toxic substances for preservation such as pesticides and glues. Staff also hope to test resources of cultural significance from local gathering areas to understand natural background levels, and whether they pose a health risk. Additionally, these instruments are useful in brownfields investigation and remediation, such as is undertaken by the Tribal Response Program, to understand where contamination exists and persists.

With these changes, the department now hosts dedicated staff to the laboratory program and operations. The long-term objectives of the laboratory program are focused into three areas: 1) support sovereignty and self-governance; 2) collaborating with agencies to understand environmental and human health risks; and 3) provide educational resources to Tribal youth. We hope that the laboratory will become a useful tool in all these capacities, where it can be a profitable entity, produce data to influence regulatory bodies, and be an educational provider.

Although the instruments are not yet installed and operational, the department anticipates renovations to be complete by April 2022. The Department wants invite the entire Tribal community and government staff to a virtual tour

> showcasing how staff are serving the Tribe within the laboratory. Stay tuned for important updates regarding laboratory capabilities and a virtual tour in the coming months!

The long-term objectives of the laboratory program are focused into three areas:

- 1) support sovereignty and self-governance;
- 2) collaborating with agencies to understand environmental and human health risks; and
- 3) provide educational resources to Tribal youth.

Operation Lady Justice

As your Police Chief, one of the responsibilities I have is to represent the Tribe within the law enforcement community to ensure that the Tribe's voice is heard and that the Tribe can be notified of upcoming issues, such as legislation, that may have an impact on how we serve the community.

One overlooked area in law enforcement nationwide the disproportionate number of missing and murdered indigenous persons (MMIP) cases that have remained unsolved. As part of Executive Order 13898, the Task Force on Missing and Murdered American Indians and Alaska Natives was created by the federal government. In addition to providing additional investigative resources to respond to MMIP incidents, the executive order also prioritized agreements between federal, state, local and Tribal law enforcement.

I will be a part of the lawenforcement sub-group for Oregon to both receive and provide insight on establishing best practices in response to MMIP incidents once it is formally established.

Please see the notice (at right) out of the Bureau of Indian affairs regarding the tipline that has been established to collect information about MMIP incidents. Feel free to share the information, and if you would like a digital (pdf) version of the flyer, please let me know and I will get it to you.

Hopefully by increasing awareness of these incidents, we can all help to achieve restorative justice and hopefully lead to a path of healing for all involved.





Live Native: Tribal Family Program



THE POWER STATE OF

Lentils With Blistered Tomatoes and Kale

Kathleen

Serves 2

Ingredients

- 1/2 pound small tomatoes, halved
- Pinch of salt
- 2 tablespoons vegetable broth
- 2 cloves garlic, chopped
- 2 tablespoons chopped shallots
- 15-ounce can lentils, drained and rinsed (or 2 cups cooked)
- 2 tablespoons balsamic vinegar
- 1/2 teaspoon salt
- 1/2 teaspoon coriander
- 1/2 teaspoon cumin
- 2 cups kale, destemmed and chopped



Directions

In a large skillet, heat a bit of oil over medium heat. Add 1/2 pound small tomatoes (cut in half) and a pinch of salt and cook for about 5 minutes. Set aside.

On medium heat, add vegetable broth, garlic, and chopped shallots and cook for 3 minutes. Add cooked or canned lentils (drained and rinsed), balsamic vinegar, salt, coriander, and cumin and stir until warmed. If dry, add a splash of water.

Add kale one handful at a time. Stir it in until wilted.

Put lentils in the bowl and surround with the tomatoes.



Positive COVID-19 Results and CTCLUSI Resources

OHA COVID-19 News Release: January 18, 2022

Oregon Reports 28, 037 new confirmed and presumptive COVID-19 cases, 10 new deaths.

PORTLAND, Ore. — There are 10 new COVID-19 related deaths in Oregon, raising the state's death toll to 5,893, the Oregon Health Authority (OHA) reported at 12:01 a.m. today.

OHA reported 28,037 new confirmed and presumptive cases of COVID-19 as of 12:01 a.m. today, bringing the state total to 541,415. Today's total also reflects the weekend and MLK Jr. holiday Jan. 17.

Are you a CTCLUSI Tribal member that has an active COVID-19 positive test? CTCLUSI has resources for members. Resources are provided to those with proof of a recent COVID-19 test, and are actively in quarantine/isolation. Resources include, yet are limited to food (frozen meals), electrolytes, cleaning supplies, over the counter

medications (we have a pre-approved list), and personal protective equipment. These resources are provided to help keep contagious Tribal members home for the 5-day quarantine/isolation period. This is an effort to help our Tribal members and help prevent the spread of COVID-19 in our community.

How to get a COVID-19 Quarantine/Isolation Kit:

- 1. Send photo proof via email or text photo proof to your local Community Health Aid (CHA). The test must be completed at a pharmacy or health care facility. Over the counter tests and home tests are not considered diagnostic by the State, and we cannot take these as proof of a positive test.
- 2. A CHA will review the COVID-19 kit checklist with the COVID-19 positive Tribal member.

Will a COVID-19 booster shot prevent me from getting COVID-19?

A COVID-19 booster shot greatly reduces the chance of being infected. And with a booster shot, being seriously ill or hospitalized from COVID-19 is very unlikely.

Will a COVID-19 booster shot prevent me from getting very sick?

the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians. I am a member of the Siuslaw Tribe and the granddaughter of Dorothy Barrett Kneaper.

I previously served on Council after being appointed spring of 2013, then successfully ran for office and served from 2015-2019. During my tenure I was a decision maker in the building of the Three Rivers Casino Coos Bay and the reorganization of the Three Rivers Casino Florence which marked the beginning of the Casino debt restructuring. In addition, the Jordan Cove project was ramping up in Coos Bay requiring the constant care and attention of the Council. I am proud to say I was just one in a long list of Tribal Members who participated in land conveyance consisting of several parcels totaling 14,742 acres. I was one of many decision makers who approved the first Dental Health Aid Therapist (DHAT) program. We have two Tribal members who are currently working in our Tribal Dental Clinic because of this program. Lastly, during my tenure, I was able to meet many Tribal members who I am honored to now call my friends. I would again like to serve on Council, as I truly believe I can help our Tribe's next steps into the future.

My 17-year career working with the Three Rivers Casinos has evolved with progressively expanding management and executive-level responsibilities to include; organizational strategic-planning, administration of multiple departments, programs and projects; development, execution, close-out and evaluation of programs and projects; budget development and fiscal

management; contract management and negotiations; policy development and implementation; risk management; human resources, workforce development and retention programs. In addition, I have served, and continue to serve, on many Tribal committees, as well as an outside nonprofit board.

I strongly believe when we treat people with respect it makes it easier to work together and get things done. Looking back, it gives me such pride when I am able to facilitate accomplishments of others. Five of the team members under my supervision have been promoted to management positions and are thriving in their new roles.

My vision for the future would be to diversify our Tribal resources and make certain we have a solid framework looking at the next Seven Generations. As the last two years have shown, we need to look at many different business opportunities so our Tribal members can be successful moving into the future.

I look forward to the time when our Tribal families are able to gather again and have that sense of community and wellbeing we have when we are together.

Bradley (Brad) Kneaper Council Position #2

My name is Bradley (Brad) Kneaper and I am running for Tribal Council Position #2. I am a Siuslaw Tribal Member and grandson of Dorothy (Barrett) Kneaper.

I believe I am qualified for this position and can help our tribe to continue to move forward in a positive and productive way.

The Tribe has come a long way since 2004 when I first came to work, including the (re)acquisition of nearly 15,000 acres of ancestral lands for us to manage for cultural and economic use. The work of our current and past Councils have led us to great accomplishments. I think there are many other things that we can do, such as:

- Hunting and fishing rights for Tribal Members, with access to our tribal forests for cultural purposes;
- Employment, housing and education for Tribal Members. Review and make sure that the processes are open and transparent;
- Economic diversity for our tribe. This is extremely important for our tribe to continue with forward progress and the economic health for future generations. The casinos provide funding for the tribal government for programs and investments however I believe that we need to have other sources of income. I have a number of ideas on ways to help push that goal forward. I believe that we should (and do) have qualified and competent people leading our business ventures, and that we should enable them to flourish and be successful;
- Transparency in Tribal Council activities. Review and evaluate possible new ways to demonstrate to all of our Tribal Communities what the Tribal Council is doing;
- Future opportunities for the Tribe and Tribal Communities. We have to be ready to evaluate and act on opportunities when they arise. We have to develop outside resources and paths of communication in order to help accomplish this. We need to listen to our people and develop paths for communication.

I hope to be able to serve you as a Council person. My life has been dedicated to public service and I have worked hard for over 40 years in various capacities, including Fire service, Emergency Medical Services, and Law Enforcement. This is a brief example of my professional history:

I retired from my position as Chief Law Enforcement Officer with Tribal Government with 34 years of law enforcement. I worked for the Tribe for just under 17 years and I have experience in working with Tribal Council, County, State and Federal Governments and law enforcement agencies.

March 1, 1987 through March 2004 I was employed as a sworn police officer by the Oregon State Police. During the 17 years and one month, I worked patrol, as a detective in several disciplines and interagency teams. I finished out my time as Patrol Sergeant/Assistant Station Commander.

April 1, 2004 I came to work for CTCLUSI as a lieutenant, and was appointed Chief of Police in 2006, to help the Tribe develop and establish a professional police department. In doing this, I promoted the tribal police department and established credibility with other law enforcement agencies. We were able to accomplishment many things. Among those were Policing Agreements with the City of Florence and Coos Bay, Coos and Lane Counties. I worked with other Tribal Police Chiefs and legal representation, and was successful getting 2011 SB 412 passed in Oregon giving qualified tribal officers full police authority on and off tribal lands. This was the first of its kind in the United States and put Tribal Police on an even footing with all other law enforcement agencies.

In June 2014 I was appointed as Chief Law Enforcement Officer/Executive Director of the Gaming Commission. In that role I continued as Chief of Police, and oversaw the Gaming Commission. The Commission ensures compliance in relation to Tribal Gaming, with the State Tribal Compact, Rules and Regulations set forth by Tribal Ordinance, Federal Law, National Indian Gaming Commission Regulations as well and Policies and Procedures of the Gaming Commission and Three Rivers Casino Resort Florence and Coos Bay.

I attended many of the tribe's family and youth camps to provide safety and security. However, the best part of these camps were the interactions with the youth of our tribe. I look forward to a time when these types of activities can resume.

I have served on the Election committee as Vice Chair and Chair, and I currently serve on the Elders Committee.

I have learned that collaboration and open communication can break down barriers and I hope to be able to use the skills I have developed in over 40 years of public service. I am proud to have worked for our tribe. The years I worked for you have been the best of my career. I hope to continue to work for you as a Tribal Council Member in Position #2.

David Petrie for Tribal Council Position #2



David Petrie has been an enrolled member of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians since 1986.

He has served as a member of several CTCLUSI committees and has successfully written Economic Development and Cultural Interpretive grants.

In 2008 he was selected by his peers as the Tribe's first Culture Director. With a strong background in business development and steady focus on reintroducing traditional culture, ceremony, arts and language he will bring a balanced approach to Tribal Council responsibilities.

In 2011 he established Coos Waterkeeper, a sanctioned Chapter of Waterkeeper Alliance. Waterkeeper Alliance is a global organization focused on improving water quality for the benefit of humanity and aquatic life. He has a strong belief that Traditional Ecological Knowledge needs to be incorporated into Tribal/Federal/State environmental management planning processes.

For the past 10 years he has been Business Development Manager for DB Western, Inc. (DBW) and directly involved with DBW deep-water offshore wind technology research and development. This included studies regarding Port of Coos Bay and Port of Umpqua geophysical assets, public/private property ownerships, environmental data sets, hydrological studies, and FAA obstruction evaluation thresholds. Additionally, he has developed strategic relationships with global leaders in the offshore wind industry, OEM Tier 1 manufacturers, and the Business Network for Offshore Wind who ushered in this new industry on the east coast. He has a long history of successfully facilitating community and corporate relationships and has developed good relationships with elected officials, Federal/State agency representatives, Tribal Governments, private industry, and academic institutions.

With a focus on environmental protection and economic development opportunities, he looks for viable solutions that benefit all citizens utilizing Traditional Indigenous Knowledge, contemporary science, and reputable business practices.



My name is Michael Romine and I am running for position #6. I am a Miluk Coos enrolled Tribal member, descendant of Mary Adamec.

I am running for Tribal council because I want to push our Tribe in the best possible economical position, while maintaining our ancestral traditions. Our Tribe has done a great job thus far, but there is always room for improvement. My ideal improvements are listed below:

Economic development

- Our Tribe has grown exponentially in the years since becoming a restored Tribe, but there has always been one thing missing in our economic portfolio and I believe that is diversity. The structures in place currently, if utilized properly can empower and assist our Tribal membership to their financial goals.
- If I am to be elected, I would work with my fellow council members to build an economic plan that stretches far past the four-year term. We have not yet reached our financial goals because we do not have a process in place that holds the next council members accountable to maintain the economic path from the previous. With open communication and a willingness to work with past and present council members towards a common goal, our Tribe will continue to grow to sustainability for the next seven generations.

Tribal Youth

- After working with the Youth Council in the capacity of Vice Chair for four years, it gave me an understanding on how important it is to have youth engagement in a Tribe. One of my main missions, if elected, is to ensure that our Tribal youth have the same opportunities I did as a youth, and more.
- Over the past two years, our communities have faced unprecedented times, which has kept our family's home and away from their Tribal community. While our Tribe has worked very hard to keep our Tribal families safe but engaged with virtual activities, it is time to bring our back families together for in person camps and activities. Our youth are the Tribes' future. With strong youth engagement and programs to support them, our community will continue to grow.

Outreach

• A Tribes biggest strength is their community of people. Knowledge for one, is knowledge for all. I believe transparency is key in the position of a Tribal Council member. Every decision made, from the purchase of land to the settling of debts affects every Tribal member. Not only do I believe we need to do a better job of keeping open and honest communication with our Tribal members, but also with the State and local governments. A healthy line of communication across the board opens doors for our Tribe that have been closed to us in the past.

As a Tribal member born into a restored Tribe, my outlook and experiences can bring forward a unique and diverse portfolio, that isn't present in our current leadership. From 2015 to 2017 I worked for our Tribal government as our Human Resources Coordinator, and several internships with the Tribal Police department, as well as Tribal Courts. In 2015, with a group of others, we were able to lay the foundation for our Tribal Youth Council. I operated as Vice Chair, until I aged out in 2020. The Tribe has helped me get to this point and the next step is our Tribal Council.

Per our constitution, it is our duty to promote and protect our unique identities as members of the Confederated Tribes of Coos, Lower Umpqua, and Siuslaw Indians, to promote and protect our cultural, religious, and historical beliefs, as well as to the social and economic welfare of our members. If elected, I will uphold the goals set forth through our constitution. It is time for change. With change comes discomfort, but with change comes growth. I am walking down the path laid for me by our ancestors and I want to lay the same path for the people that come long after me.
