Qualifications:

While serving as the CTCLUSI Director of Health & Human Services for 8 years, I am proud of several major accomplishments, including but not limited to:

- ♦ Consistently outperformed our department budgets.
- Under my management, the CTCLUSI Dental Clinic began to generate positive revenue.
- Completed a major remodel and expansion of the CTCLUSI Dental Clinic without using money from the General Fund.
- ♦ Established the Dental Therapy program at CTCLUSI (the first one in Oregon).
- ♦ Achieved \$300 thousand in annual pharmacy cost savings.
- ♦ Continued to maintain service levels to Tribal members without any cuts to established programs.
- ♦ Established a summer produce program (through our Administration on Aging grant) for Elders living in the five-county service delivery area.

Caroline was a Roseburg allottee whose allotment was in what is now part of Shore Acres State Park. Caroline's mother was Hanis Coos and her father was Lower Umpqua. My Tribal lineage is Caroline (1845-1904),her daughter Susie (1880-1900). granddaughter Dora Goodman (1893-1975), greatgranddaughter Florence Lambert (1917-2000), and 2x great-granddaughter Wanda Hughes (my mother).

Grants I Helped the Tribes Receive

- * Circles of Healing program serving the needs of American Indian/Alaska Native (AI/AN) women who are victims of intimate partner violence, dating violence, stalking, and trafficking.
- * Oregon Youth Development Council funding for Healing of the Canoe, Canoe Journey, and Tribal youth activities, including purchase of the food truck.
- * SAMHSA Native Connections grant of \$300 thousand annually to develop a comprehensive program for Native youth up to age 24 to reduce suicide risk, reduce substance abuse, and support youth as they transition into adulthood.
