

Hunting, Fishing & Gathering by CTCLUSI Tribal Members: Need of General Council Authority to Negotiate Agreements and Issue Permits Related to

Hunting, Fishing & Gathering on Tribal and Non-Tribal Lands



constitution shall be construed as restricting the exercise of hunting, fishing, or gathering rights of members, to the fullest extent permitted by law. No tribal decision affecting such hunting, fishing, or gathering rights shall be made except by a full vote of the membership." Tribal Elders who were involved in drafting the Constitution tell us that this language was intended to prevent the Tribe from giving up its hunting, fishing, or gathering rights without a vote by the membership. Unfortunately, the broad language contained in the Constitution prevents the Tribe from acting to promote and protect the rights of Tribal Members, even when such action would not diminish the rights of Tribal Members and in fact might enhance those rights.

For example, the Tribe currently does not have the authority to issue hunting, fishing, or gathering permits to Tribal Members. As a result, any Tribal Member who hunts, fishes, or gathers on tribal lands is in violation of state and federal laws that prohibit these activities without first obtaining a State License or permit. While the Tribe does not enforce these state and federal laws against Tribal Members, any Tribal Member who engages in these activities without a permit risks prosecution by state and federal authorities.

In addition, the Tribe also lacks the authority to enter into

agreements with other entities, like the State of Oregon, to protect and promote the hunting, fishing, and gathering rights of Tribal Members. One example of such an agreement is the recently announced agreement between the Coquille Indian Tribe and the State, allowing the Coquille Tribe to issue hunting, fishing, and trapping permits to its Tribal Members, and establish their own Tribal Hunting and Fishing Regulations within their five -county service area. These tags will provide additional hunting opportunities to Coquille Tribal Members free of state regulation. The agreement does not diminish any of the Coquille Tribe's hunting rights. The State has invited the Tribal Council to negotiate a similar agreement, but the Council is currently prohibited from negotiating and entering into such an agreement without a full vote of the membership.

Proposed Solution

In order to promote and protect the traditional rights of the Tribal Membership, the Tribe wishes to establish a Tribal Hunting, Fishing, and Gathering Code. This Code would direct the Tribe to negotiate and enter into agreements with the State, recognizing the special hunting, fishing, and gathering rights of Tribal Members. It is anticipated that under these agreements,





Tribal Council Corner

Dear General Membership,

Along with 20-30 other general Tribal members I was thankful, grateful and blessed to participate in our Annual Salmon Allotment process. Ashley Russell and Tyrell Walton drove one of our CTCLUSI vehicles to and from our Coos Bay Administrative area to the Lost Creek Hatchery July 16, 2022. This year they were able to bring us 116 Rogue River Chinook Salmon back to the Community Center fish cleaning area. There 20-30 CTCLUSI and non-tribal volunteers had gathered to bless, clean and store the fish in the appropriate CTCLUSI protocol.

As one of our 1316 general tribal members, I was inspired by the solid number of both CTCLUSI general members and nontribal members who were able to turn out to participate in this process. While our Chief Doc Slyter was not able to be with us in person this year, we included him as well as all CTCLUSI general membership in our prayer of thanks to our creator for the abundant allotment we received. The ages of the participants ranged from a very young one year old member to one elder fortunate to have so far reach 82 cycles around the sun. Family relationships ranged Grandfather/grandchild, Auntie/ from nieces and nephews, Mothers/children. All volunteers worked together energetically and, collaboratively to process the salmon in the timely manner they needed us to. They came in around 4:45 p.m. and were



blessed, cleaned and, stored by 7:45p.m.

Because this is one of our annual ceremonies please note if you were not able to participate this year perhaps you can next year. This year was only the second time I was fortunate to be able to participate. Those who are expert at cleaning the fish are open and willing to teach those of us who do not know how. The children run the fish needing to be cleaned to the cleaners. The children also run the

cleaned fish back to the holding bins where the cleaned fish are stored until they are taken to be flash frozen. Also, because we are salmon people, I think it is a valuable spiritual experience for all of us CTCLUSI general members to experience.



the State and the Tribe would work cooperatively to establish a framework for issuing additional hunting and fishing permits to Tribal Members. These agreements would not give away or reduce any of the Tribe's hunting, fishing, or gathering rights. Hunting and fishing permits would be issued by the Tribe and would protect Tribal Members from prosecution under state and federal law.

The Code would also direct the Tribe to develop a permit system for the gathering of minor forest products in the Tribal Forest. Under this permit system, Tribal Members would be able to obtain Tribal permits to gather most forest products in the Tribal Forest. These permits would contain provisions designed to protect and conserve resources on the Tribal Forest – for example, allowable locations for firewood cutting. By carrying these Tribal permits, Tribal Members would be able to ensure that that state and federal laws do not infringe on their ability to utilize the Tribal Forest Lands.

Finally, the Code would authorize the Tribe to negotiate agreements with non-Tribal landowners, which would recognize the ability of Tribal Members to access those lands for the purposes gathering minor forest products. These agreements could apply to National Forest Lands, State Forest Lands, and private industrial forestlands. As one example, the Oregon Department of State Lands and Oregon State University have expressed interest in entering into an agreement with the Tribe that would acknowledge the rights of Tribal Members to gather minor forest products on the Elliott State Research Forest. Like the Tribal Forest permits, these agreements would contain provisions intended to conserve and protect resources on those non-Tribal forestlands.

Conclusion

The Tribal Council is currently drafting a Tribal Hunting, Fishing, and Gathering Code that would authorize the Tribe to negotiate and enter into agreements related to hunting, fishing, and gathering activities by Tribal Members. The agreements would serve to promote and protect the rights of Tribal Members. The Code would not allow the Tribe to give away any of its hunting, fishing, or gathering rights. In order to comply with Article II of the Tribal Constitution, this Tribal Hunting, Fishing, and Gathering Code will need approval from the Tribes' General Council.

The Tribal Council has directed the Hunting Fishing and Gathering Ad-Hoc Committee to first review and comment on the Draft Code and will then call the Election Board to hold a Special Election by Resolution.

Article VI, Section 3 of the Tribes' Constitution states that it is in the General Council Authority, that before taking any action with regard to the diminishment, negotiation or settlement of any hunting, fishing or gathering rights possessed or claimed by CTCLUSI, the Tribal Council shall obtain the approval of \(^3\)4 of the membership in a vote in which at least 35% of the membership participate. Such vote will be taken

To enable and adequately protect Tribal Members' rights to hunt, fish, and gather, these above described steps are needed. At this time there are 914 eligible voters, of which at least 320 voting members must participate in this Special Election. For this issue to pass at least 240 members must vote in favor. Therefore, it is imperative that you vote in this special election when you receive the ballot.

Fire Season in Effect Please Help Protect the Tribal Forest from Wildfire

Fire season is currently in effect in Western Oregon. Although we've had a wet spring, forest fuels can dry out quickly and provide conditions that are ideal for wildfire to spread. In fact, Coos Fire Protection Association (CFPA) responded to a 40acre fire near Langlois on June 22nd, days before fire season officially began. CTCLUSI staff participated in the control of this fire as part of a training exercise with CFPA, and we were surprised to see how easily the fire spread so early in the season.

Along with fire season comes Public Use Restrictions, which are designed to prevent human sources of wildfire. Smoking, the use of fireworks, mowing

of dry grass, and the use of campfires or barbeques outside of approved areas are prohibited under these restrictions. The restrictions also require all vehicles to carry fire tools when traveling on forest roads. A matrix showing all of the Public Use Restrictions is shown on page 7 of this publication.

Please keep in mind that the Tribe has not approved any designated areas for campfires or barbeques. As a result, all campfires and barbeques are prohibited on the Tribal Forest at all times.

In addition to these Public Use Restrictions, CTCLUSI has instituted a standing closure order for all areas of the Tribal Forest where the Industrial Fire Precaution Level (IFPL) is at Level II or higher. This closure is necessary to protect the Tribal Forest from the risk of loss due to wildfire.

IFPL's are updated throughout fire season by the Oregon

Department of Forestry - Western Lane District (ODF) and CFPA, which are both responsible for protecting the Tribal Forest from wildfire. ODF and CFPA monitor fuel moisture levels as well as weather trends throughout fire season, and adjust the IFPL's accordingly. The table below shows the Fire Protection District (or Association) and Fire Protection Zone for each of the Tribal Forest tracts.

Because IFPL's change throughout fire season, it is important to check on the current IFPL level before you visit the Tribal Forest. If the IFPL is at Level II or higher, the Tribal Forest is closed to protect the Tribes' forestlands from wildfire.





What is 988?

988 is a direct three-digit line to trained National Suicide Prevention Lifeline crisis counselors that will go live July 16, 2022. With an easy to remember 3-digit number, the Lifeline hopes to reach many more people in emotional crisis. This service is provided free of charge to the caller. Any person of any age can call or text 988; services will be available 24/7, year round. They will include a text option, translation services for non-English speakers, accessible options for people who are deaf or hard of hearing, and services for minors.

When you've got a police, fire, or rescue emergency, you call 911.

When you have a mental health emergency, you call/text 988.

Why do we need 988?

Suicide is the second leading cause of death for Native youth ages 10-24. Native communities experience the highest rates of suicide amongst all racial and ethnic groups in the Unites States, and suicide rates among American Indian and Alaska Native communities rose by 118% between 1999 and 2017.

Suicide is preventable. 988 is one step in the direction of saving lives. This early intervention can reduce the burden on 911 and hospital services. 988 will move mental health and substance use services out of the shadows and into the mainstream; it will send a message that healing and getting help are normal and important parts of life.

PROTECTING OUR WAY OF LIFE: CTCLUSI CALLS FOR BOEM TO AVOID IMPACTS TO TRADITIONAL USES, SITES AND CULTURAL RESOURES

News Release - Coos Bay, Ore. On June 28, 2022, the Confederated Tribes of the Coos, Lower Umpqua and Siuslaw Indians submitted comments to the federal Bureau of Ocean Energy Management (BOEM) expressing significant concern about proposed development of offshore wind energy off the Oregon Coast in areas designated by BOEM as the Coos Bay and Brookings Call Areas. If Offshore Floating Wind moves forward in these Call Areas there will be negative impacts to CTCLUSI resources, sites and uses both onshore and in the ocean. While many see green energy as synonymous with low impact development, floating offshore energy development is anything but; therefore, the Tribe recently provided extensive comments to the BOEM Oregon Call for Information for the two offshore areas encompassing 1,159,298 acres.

"The Tribe supports any green economic development project that follows the law and does not harm our environment or Tribal cultural resources." said Tribal Council Chair Brad Kneaper. The Chair also stated that "The federal government must engage with the Tribe to address our concerns. BOEM has stated that it worked closely with Tribe. While there has been engagement with the Tribe, this engagement has been a one-way conversation with BOEM providing information to the Tribe."

In a January letter to BOEM the Tribe requested the Bureau exclude areas of significant cultural importance to the Tribe. However, in an April notice BOEM included these areas anyway, without engaging in government-to-government consultation with the Tribe. Subsequently, CTCLUSI comments and resolution in June "reiterate [our] expectation that BOEM uphold its trust obligation to protect Tribal resources and exclude those areas. If BOEM does not, the Tribe will need to look at all opportunities to ensure that wind energy development avoid impacts to resources that are important to the Tribe" Chair Kneaper summarized in a recent press release.

We know that if offshore wind energy moves forward in Coos Bay or Brookings impacts could be substantial and disproportionate for Tribal citizens. So far, BOEM has not provided adequate responses to CTCLUSI concerns or requests, and thus, the Tribe has been engaging more actively with BOEM, State Agencies such as the Department of Land Conservation and Development (DLCD), Oregon Department of Energy (ODOE), Oregon Department of

Fish and Wildlife (ODFW), as well as the Udall Foundation—whom has received funding from BOEM to assess Traditional Cultural Landscapes—and at public meetings.

Thus far, the Tribe has raised a number of concerns about offshore wind energy development. These comments include a request that important, cultural viewsheds be excluded from the Call Areas, that wind development, including necessary infrastructure such as transmission lines, not impact areas designated as a Traditional Cultural Property, Q'alya ta Kukwis shichdii me (located in Coos Bay comprised of the estuary features and adjacent shoreline resources), that development not occur in areas containing cultural features located on submerged landforms, and that wind development avoid areas critical to resident and migratory species, including important areas for fishing.

To affirm areas of concern and interest in protecting ocean uses and resources, Tribal Council, at their June 12, 2022 meeting, unanimously approved resolution 22-087 which calls upon BOEM to engage in meaningful government-to government consultation with the Tribe and to take action to ensure that offshore wind energy development in any area of interest to the Tribe avoids or mitigates impacts to Tribal cultural resources to the satisfaction of the Tribe.

The Tribe has called the coast our home since time immemorial. Our religious beliefs, traditional practices, fishing, first foods and relations are interconnected and influenced by all that is encompassed in the greater Ocean. This claim honors our obligations to uphold our sovereignty, perpetuate our unique cultural identity, and promote the intergenerational transference of knowledge. The Tribe consistently advocates that any projects, on land or offshore, avoid impacts to sites of traditional and religious significance to the Tribe, including the cultural features and sites, including viewsheds, resources, and submerged landforms that possess associations with the cultural practices, traditions, beliefs, lifeways, art, crafts, or social institutions of our living community. The Tribe remains open to working with the Bureau to find opportunities to resolve potential impacts to our uses, resources and sites.

Mouth Guards: Sports Equipment That Protects the Smile

With school starting soon, it's time to start thinking about sports and protecting student's smiles. It's easy to take some things for granted until they're suddenly gone. Have you ever thought about how it would feel if you lost one or two of your front teeth? You'd probably avoid smiling. It would be uncomfortable talking with someone face-to-face. It wouldn't be easy pronouncing certain words. How about eating an apple? Until your teeth are gone, you might not miss them. How would you replace those missing front teeth and how much would that cost?

Each year, thousands of teens get hurt on the playing field, the basketball court, or while skateboarding, biking or during other activities. Blows to the face in nearly every sport can injure your teeth, lips, cheeks and tongue. A properly fitted mouth guard, or mouth protector, is an important piece of athletic gear that can protect your teeth and smile. You may have seen them used in contact sports, such as football, boxing, and ice hockey. However, you don't have

to be on the football field to benefit from a mouth guard. New findings in sports dentistry show that even in non-contact sports such as gymnastics, rollerblading and field hockey, mouth guards help protect teeth. Many experts recommend that a mouth guard be worn for any recreational activity that poses a risk of injury to the mouth.

There are three types of mouth guards:

- the ready-made, or stock, mouth
- the mouth formed boil and bite mouth guard; and
- the custom-made mouth guard made by your dentist.

All three mouth guards provide protection, but vary in comfort and cost. The most effective mouth guard should have several features: It should be resilient, tear-resistant and comfortable. It should fit properly, be durable and easy to clean, and not restrict your speech or breathing. Generally, a

mouth guard covers only the upper teeth, but in some cases the dentist will instead make a mouth guard for the lower teeth. Your dentist can suggest the right mouth guard for you.

Here are some suggestions for taking good care of your mouth guard: Before and after each use, rinse it with cold water or with an antiseptic mouth rinse. You can clean it with toothpaste and a toothbrush, too. When it's not in use, place your mouth guard in a firm, perforated container. This permits air circulation and helps prevent damage. Avoid high temperatures, such as hot water, hot surfaces or direct sunlight, which can distort the mouth guard. Check it for tears, holes and poor fit. A mouth guard that's torn or in bad shape can irritate your mouth and lessen the amount of protection it provides. Have regular dental checkups and bring your mouth guard along so the dentist can make sure

it's still in good condition. Don't take your teeth for granted. Protect your smile with a mouth guard.
