

On site visit to, Qa'aich site on the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians Hatch Trust property Florence Oregon July 21, 2022 by Tribal Council members Doug Barrett, Teresa Spangler, Chair Brad Kneaper and, Vice Chair Julie Siestreem at the invitation of DNR specialist Kyle Terry. Kyle coordinated a cleanup project with Eugene 4J teacher Naz, from Kalapuya High School's Summer Youth Work Program for this area. Kyle and Naz worked with the students to remove overgrown blackberry vines, scotch broom, gorse and, assorted other invasive plants from the area. Some heavy equipment was brought in to do some of the major lifting however, most of the work was done by hand with simple gloves, shovels and cutting tools. Conversations were exchanged for the possibility that a ongoing relationship may be established between CTCLUSI and Kalapuya High School for this kind of upkeep and maintenance work to be done on a regular monthly, bi-monthly, quarterly and or, annually basis for this site.

As one of the seven Tribal Council members I was allowed to attend a one salmon ceremony held at Gregory Point August 7, 2022 with Chief Doc Slyter, Chair Brad Kneaper and, fellow Tribal Council member Enna Helms. Brad fileted the salmon and set it on the stakes over a small fire set in the regular big fire pit. Debbie Slyter made and shared her "hot egg salad" and, Enna Helms made her delicious fry bread for our Salmon Ceremony meal. I walked out to the edge of the property and sent up personal prayers for all of us, for continued good health, speedy recovery for those who need it and, support for those of us dealing with grief for those we have lost. It was an absolutely beautiful sunny day all day. Chief led us in prayer before the meal. We chose to put the bones into the ocean below our Coos Head property near the jetty. Chief said another prayer as we did this. COVID -19 has created a world change in how we are gathering that is more than challenging for all of us. Because I was one who is fortunate to have attended our annual Salmon Ceremony Pre-COVID-19 with 200 plus members present on our Gregory Point land areas while I was thankful to be allowed to be there August 7, 2022, it was a bittersweet day. We are a social gathering people. I humbly look forward to the time we can all gather in person safely again on a regular basis for all of our ceremonial, cultural, educational and, mixed activity events.

The Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians (CTCLUSI) invites the public to review and comment on the Tribe's draft Water Quality Standards (WQS). WQS are science-based criteria describing the conditions necessary to sustain healthy human and aquatic life within the Tribe's waters. These WQS apply only to waters within the boundaries of the Tribe's trust and reservation lands and are not applicable to public or privately owned waters of the State of Oregon.

The CTCLUSI Department of Natural Resources (DNR) will hold a public hearing at 6:00 PM Pacific Time on September 21st, 2022, for the purpose of hearing comments and recommendations on the development of Tribal Water Quality Standards.

The purpose of this study is to understand shellfish harvesters how view their risk of shellfish poisoning caused by harmful algal blooms (HABs), and to understand their preferences for management of fisheries during harmful algal blooms. # Simple Ways to Stay Cool:

- Try putting a wet washcloth or cooling cloth around the back of your neck (stick in the freezer for extra cooling).
- Avoid the sun, especially between 11 am and 2 pm. If you have to be outside, try finding shade, wear sunglasses to protect your eyes, and remember sunscreen with an SPF of 30 or higher.
- If the heat is extreme, please stay indoors. Ask a family member for help or contact your local CHA for assistance.
- Have a constant airflow (fans or air conditioners).
- Keep your feet cool! Wrap them in a cool, wet rag, or dip them in the tub with cold water.
- Wear loose, lightweight breathable cotton clothing.

- Do not over-exert yourself. Warm days
  make it much easier for someone to exhaust
  themselves and overheat from doing too many
  chores. Pace yourself and take lots of breaks to
  cool down and drink fluids
- Most importantly, stay hydrated! Water is always your best option. Try adding lemon juice or infused fruit for a little more flavor. Electrolytes help as well but be aware of the sugar contents. Gatorade and Body Armor have sugar-free options. Add ice for more cooling.

Whatever you do, do not shock your body and go from hot to cold too quickly.

# How to Help PRC Pay Your Bills!

An (EOB) Explanation of Benefits comes from the insurance company that shows you how the costs are distributed. Remember the EOB is not a bill.

# Claim detail section:

- This is the main section of your EOB that shows you how costs are distributed for services you received.
- Name of the Doctor who provided the service and date of service.
- Description of the service and the total cost billed.
- The breakdown of what your insurance company pays, the amount your insurance company will allow for the service billed, the amount the Doctor's office needs to write off, and the amount that is the patient responsibility.
- If the insurance company is denying the claim they will list the reason for denial.
- Please hold on to your EOBs from your insurance company. PRC may need to obtain a copy from you if we are unable to obtain this from the Doctor's office.

• PRC is a payor of last resort. We rely on your Doctor's office to send us the claim in order for us to pay.

#### **Statements- from your Doctor's office:**

- Your doctor's office might send you a statement. A statement shows how much your doctor's office billed your insurance company for the services you received and how much money you owe. Did you know that quite often if you are seen at a hospital and have lab work or x-rays additional charges will be billed from other facilities? These facilities more often than not, are not given any of your billing information. This is why it is important to look at your statements when they come in and make sure they are billing all of your insurances and PRC.
- If you have primary insurance and you receive a statement from your doctor's office before your insurance company pays, you should contact your doctor's office to make sure they have all of your insurance information for billing. Watch for an EOB to match up with the statement.

• After your insurance company pays your doctor, the balance should be billed to Purchased/Referred Care if you have filled out your yearly PRC application. If you receive a statement with a balance, they more than likely have not billed PRC appropriately. Please contact your Doctor's office and provide the billing information for CTCLUSI:

• If you have made contact and received a second statement please reach out to PRC so we can assist in getting the claim to us for payment.

# What is a Dental Hygienist?

According to the American Dental Hygienists' Association out (ADHA), a dental hygienist is an oral health professional responsible for preventing and treating oral diseases. Prior to having the honor of helping people improve their oral health, dental hygienists have spent several years studying and testing in preparation for treating patients.

In order to practice as a dental hygienist, students must first graduate from an accredited school of dental hygiene with either an Associate's or a Bachelor's Degree in Applied Science.

During this course of study, classes such as anatomy, physiology, microbiology, and chemistry must be passed. This is in addition to core classes like math and English, prior to starting the specialized dental hygiene classes. Dental hygiene classes include oral pathology, tooth morphology, and periodontology. All strange new terms at first, that become second nature over time.

Once school has been completed, dental hygienists must then pass a 350-question national board examination, which can include questions on anything science or dental hygiene-related plus case studies. Each state also requires a regional or state board examination on a patient approved by the board. Sometimes the prospective dental hygienist and the patient have to travel hundreds of miles and work in an unfamiliar clinic under the watchful eye of examiners. Talk about stressful! (Interesting note: During the pandemic, students were/are allowed to use manikins for testing)

Once all these criteria have been met, the student can be licensed and use the designation of Registered Dental Hygienist (R.D.H.). Each state has its own laws regarding what procedures dental hygienists can perform, license renewal, and continuing education requirements. I recently applied for and received my Oregon Expanded Practice Dental Hygiene Permit, which allows me to see most dental hygiene patients without a dentist present. This will prevent a lapse in dental hygiene services should the CTCLUSI Dental Clinic be without a dentist in the future.

Are you or someone you know interested in a career in health care? Have an aptitude for science? Maybe dental hygiene sounds intriguing. The profession has certainly been very rewarding to me. 

You **MUST** be a registered voter to receive and participate in the Special Election. Per the Constitution we must have a minimum number of participates to be considered a valid election.

# Tribal Elder Frances "Sue" Perry Olson Walks On

On July 30th, 2022, our beloved Frances "Sue" Perry Olson, 84, was part of the Tribal Forest Core Group that created the proposal passed away peacefully at home in Veneta, Oregon.

Sue was the great-granddaughter of Huldah Macy Perry, a Lower Umpqua Indian lady born in 1857 at Fort Umpqua.

Sue was born in Myrtle Point, Oregon and moved away at a young age. Spending most of her life in the Eugene area,

Sue always knew she was of Native American descent and was very interested in her tribe, even before the Confederated Tribes were restored. Fascinated by her ancestry, Sue decided she would like to learn some of the cultural aspects of her heritage through Native crafts. In the 1970's, she ordered her first beads from a trading company in Colorado, bought a couple of books and began to make a rosette.

Sue became involved with the tribe in 1975 by traveling from Eugene to Coos Bay to attend tribal meetings for the Tribes' Restoration. She was a member of the Tribal Health Board Committee from 1987 to 2017. She also served as a member of the Election Board Committee and the Enrollment Committee. In April 1995, she was elected to a position on the Tribal Council and served the full term of 4 years. During that term, Sue also served 6 months as Vice Chairman on the Council.

Sue invested her time with training sessions to preserve Tribal history and public education of Native Culture. She was appointed as a member of the Bal'diyaka Foundation Board and for the Land Restoration Bill.

She spent extensive time researching her ancestors. Reviewing historic documents, photographs and artifacts, which increased her knowledge of the Tribe's Native custom, dress and decorations and helped her to complete her regalia. By looking at those

> photos, she figured out how to make her beaded collar, a part of her regalia. Throughout the years, she helped many of our Tribal Members make their own beaded collars as part of their regalia.

> > Sue was proud her work was exhibited. She was especially excited for her exhibit in the Confederated Tribes' Laquawiyat' as Gallery. " One Bead at a Time, A Lower Umpqua Woman's quest for what was", where her work was shown.

> > She is survived by her son Steven Olson and grandchildren, Jessica Olson, Nicholas Olson and Violet Olson. She was proceeded in death by her parents, John W. Perry Sr. and Adeline Perry-Stephens, her husband, Robert Olson, and brother, John W. Perry Jr.

No memorial services will be held, but Sue was laid to rest at Lane Memorial Gardens on August 4, 2022 with family and friends present.

She was loved by many people and will be missed.

# Tribal Elder John W. Cauthorn Walks On

Today he's gone home and we've lost one of the most influential, courageous and profoundly good human beings that any of us will share time with on this Earth. He no longer belongs to us; he belongs to the Creator.

John W. Perry II – Cauthorn was born 12/02/1957 in Lajolla, California, the Creator called him home on June 7, 2022

in Florence, Oregon at the age of 64.

John went to the Wyatt Elementary before being transferred to the Lake Creek Mennonite school, near Harrisburg, OR. John graduated high school from Central Linn HS, in Halsey, OR. From there he attended refrigeration classes at Lane Community College.

John lost his left eye at the age of 9 from a piece of glass.

John was a member of the Lower Umpqua Tribe (Tribal member of the Lower Umpqua Indians), John knew the land like the back of his hand, John found the petroglyphs in the cliffs and many tools, utensils other items like spear points, arrow points, bear claw necklace, and other items including a rock arrow straightener at a village site on our aboriginal land. John was an avid story teller of the old ways, did rock mapping, poem writer, he served on Tribal Council, worked in Tribal HUD

Maintenance, served on the Educational Committee for several years and went on to work in the Tribal Cultural Department. John was very knowledgeable in both the history and culture of the Lower Umpqua Tribe and also of the other local tribes, Coos, Siuslaw, Cow Creek and others. John was very protective of our cultural sites and wanted to assure they were protected, especially important him was Tkímiya, Umpqua Eden.



John was most proud of his animal's especially Jaz and Leiben his dog. If you were lucky to have John as a friend, son, brother or husband you had a bond for life. He is survived by his sister "Jennifer" Mea Portillo, Roseana Perry, his brother Paul Cauthorn, and his niece Charlotte Kennedy, his nephew David Mallory and his three great nephews Conway Mallory, Le'Ryann Kennedy, and Lorenzo Kennedy.

He also leaves behind a very special friend Wendy Garcia who helped John alot through his final years and days.

John was preceded in death by both of his parents John Walter Perry Jr. Passed June 7, 2020, and Sheila Leon Perkins Perry Cauthorn Lowe passed March 31, 2018. His Grandparents were John W. Perry Sr. and Adeline "Addie" Ida Perry – Stephens.

There will be no funeral service. John was cremated and his ashes scattered by his sister Mea around the Scotsburg area near the petroglyph's and old village site. Not far from Dean's Creek area where John use to live.


In accordance with CLUSITC 7-1-37(a), Tribal Members shall have the right to protest the recommendation of the Committee approving an application and must file a written, signed protest with the Committee stating their reasons for believing that an Applicant(s) is not entitled to enrollment. The protest must be filed with the Committee within twenty-eight (28) days after notice of the proposed enrollment is posted as described in CLUSITC 7-1-36(i).





# **What is 988?**

988 is a direct three-digit line to trained National Suicide Prevention Lifeline crisis counselors that will go live July 16, 2022. With an easy to remember 3-digit number, the Lifeline hopes to reach many more people in emotional crisis. This service is provided free of charge to the caller. Any person of any age can call or text 988; services will be available 24/7, year round. They will include a text option, translation services for non-English speakers, accessible options for people who are deaf or hard of hearing, and services for minors.

When you've got a police, fire, or rescue emergency, you call 911.

When you have a mental health emergency, you call/text 988.

# Where Are Our Indian Children

Across the Nation, 70% to 75% of all Indian children removed from their Tribal families never reunify with their parents. These children do not always have relatives to care for them so they are placed with non-Indian families.

When these children grow up without a connection to their traditions and culture they lose their identity as tribal people. Tribes have always struggled to find families willing and able to care for these children and as a result Tribes are losing their history and their future. You may wonder what you can do, how can you help? CTCLUSI is making efforts to connect Tribal families with Tribal children so that we can help heal the separational trauma these children have to endure.

Like this basket we are all connected to one another made strong intertwined to build on and establish one connective basket. As a Tribal community we are not individuals, we are one peoples and if we don't put our arms around these children who will?

# Tribal Member Tennepah Brainard Honored by City of Eugene for Photography Installation

Miluk Coos Tribal member Tennepah Brainard was recently two years, placing her on the President's List each semester. honored with recognition by the City of Eugene and the local Indigenous Community for her photography installation,

"Culture Rising" at Riverfront Park. The Park was opened in concert with the OR22 National Track championships, and over 25,000 people visited the park in two weeks.

The Culture Rising installation was a tricky project in that it was designed and completed during the Covid pandemic. Tennepah's concept has been to show the breadth and depth of Native heritage and people with the work. Due to lockdown, Tennepah was not able to photograph the participants in person. Rather, she directed the lights and shadows photography via Zoom and phone conversations. Tennepah said that the inability to photograph in person "added a huge extra layer of complexity" to the project.

Once the photographs were completed, Tennepah manipulated the photos to design the 100 ft long installation. She said that her goal was to demonstrate the connection of youth with elders, which is important in Tribal Culture, as well as show that Indigenous people live in the local community. She also wanted to share how much the family participants look like on one another and are also unique individuals.

Tennepah is starting her third year at IAIA (Institute of American Indian Art) in Santa Fe. She has received straight A's for her first

Tennepah's career choices are fluid right now, but she wants to always be able to include her photography and art into any future job.

# Language Revitalization Project

Tribal member Jade Fong has received a small grant funded by the U.S. Department of State to carry out a language revitalization project involving documentation and storybook creation.





In 2019, Jade received the Benjamin A. Gilman Scholarship towards her study abroad program at Yonsei University in Seoul, South Korea. As an international exchange alumni, she was eligible to apply for a seminar hosted by the Alumni Thematic International Exchange Seminars (Alumni TIES)gatherings for U.S. government-sponsored exchange program alumni to network and learn about current foreign policy or public diplomacy topics. Jade was accepted in March of 2022 to attend one in Minneapolis on "American Identity: Exploring Our Collective Memory, Heritages, and Histories." Seminar participants were eligible to receive a grant of up to

\$10,000 pertaining to the theme, which Jade has successfully applied and received funding for. Her grant project focuses on CTCLUSI language revitalization where she will 1) document current revitalization efforts via interviews with tribal language speakers and learners and 2) create a children's storybook in all three tribal languages. She hopes that recording this historical endeavor will provide a blueprint for future language revitalization programs. She is working with two tribal linguists—Enna Helms and Patty Phillips, and welcomes volunteers who may want to be involved or have any suggestions to add.
