## *Three Rivers Foundation Awards \$1.1 Million To More Than 100 Oregon Nonprofits*

**FOR IMMEDIATE RELEASE: Three Rivers Foundation Awards \$1.1 Million To More Than 100 Oregon Nonprofits**

Florence, Ore. -- The Three Rivers Foundation, established by the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians as the charitable arm of its Three Rivers Casino Resort, awarded \$1.1 million in funding to 117 organizations in Oregon.

Three Rivers Foundation is honored to impact the missions of these nonprofit organizations. With almost ten thousand nonprofits operating in Oregon, funding is crucial. The Foundation received a major increase in applications this year, allowing it to grant 62 nonprofits first-time grant funding.

"It makes my heart feel good," said Doug Barrett, Tribal Council member. "It feels good getting to see what these organizations are doing with the money, whether it be the food banks, helping the youth through their struggles, whatever the money goes, it is pretty awesome."

The Three Rivers Foundation supports innovative ideas, collaborative approaches and grassroots efforts in education, health, public safety, problem gambling, the arts, the environment, cultural activities and historic preservation.

Several members of the Tribal Council were present at a February

16 luncheon at the Florence Casino held to honor the grant recipients.

"When I have a rough time throughout the year, "I think of today as a positive energy that's going on in this room, helping the community, bringing the community together, and strengthening it. What a positive thing to do," said Chief Doc Slyter, Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians.

The Cascades Raptor Center was one of the 117 nonprofits to receive funding. The Foundation awarded the popular center \$10,000 to expand its educational programming.

"Now we will be able to serve more communities, rural communities who don't have the means to rent buses or make it to the raptor center for education," said Jennifer Monegan, Senior Development Officer Cascades Raptor Center. "It's such an incredible gift to the community from the Three Rivers Foundation."

Children's Repertory of Oregon Workshops (C.R.O.W.) received \$21,000. It will use the funding to support its main stage musical, The SpongeBob Musical. "It's amazing, and we are so grateful for the funding," said Melanie Heard, founder of C.R.O.W.

"The Three Rivers Foundation is incredible! They do so much for the community; every need has been met and is truly touching. The arts are really important, and it was very special that the Three Rivers Foundation recognized that."

Boys and Girls Club of Western Lane County received \$25,000. It plans on using the grant to fund its outside healthy habitat for its kids and teens to use in the cold and rainy winter and spring

# Tribal Council Corner

Hello everyone,  
I am Brad Kneaper, your Tribal Chair.

I would like to give an update on the Constitutional Amendment process that we are considering. On January 28, 2023, Tribal Council met with legal to go over the Constitution to discuss possible areas that may need to be updated. Keep in mind that this is a difficult and complicated process, and this short article cannot capture all the information. However, there will be more information coming. Additionally, if and when this vote happens, you will have the option to vote for each proposed amendment individually. If you agree with one you can vote yes, and not another you can vote no on that one. You will also have the opportunity to provide feedback prior to the vote both virtually and in written format. Any amendments will be approved by tribal membership, not Tribal Council.

At the Sunday, February 12<sup>th</sup> Regular Council Meeting, a couple Tribal Members spoke to Council that they were unclear on this process and reported that they had heard that there was a 'fear' among other Tribal Members that this was a move to "disenroll" people from the Tribe. This could not be further from the truth, and in fact just the opposite. There are currently some issues in the constitution that prohibit enrollment of people that are clearly entitled to be enrolled. While you will be getting further detail, we are looking at verbiage similar to the verbiage in the Restoration Act that was not carried over to the Constitution that made the Constitution more restrictive. To reiterate, there is no one seeking any actions of disenrollment of any Tribal Members, or to prohibit the enrollment of anyone entitled to be a member of our Tribe.

A few have asked where we are with the Hunting and Fishing co-agreement agreement. The next step for is a presentation to the state Fish and Wildlife Commission in April. Once that happens, we will update membership with any information that becomes available.

Be safe everyone, and we will keep everyone up to date on these topics and others.

# Offshore Wind Energy: Tribal Engagement in the Planning Process- Where are we now?

On January 26, 2023 CTCLUSI Tribal Government met with the Bureau of Ocean Energy Management (BOEM) for government to government consultation. This meeting came just one month shy of a full year since BOEM issued the "Call Areas" off the Oregon Coast. CTCLUSI has written many letters in response to BOEM moving forward with exploring offshore wind energy on the Oregon Coast. At this meeting, Tribal Council and staff expressed concerns of the impacts to our ocean viewsheds, submerged landforms and their associated features, resident and migratory species, and our local fisheries.

On June 12<sup>th</sup>, 2022, CTCLUSI passed resolution No. 22-087, expressing limited support to offshore wind energy development in the Coos Bay and Brookings Call Areas. CTCLUSI called upon BOEM to engage in meaningful government-to-government consultation with the Tribe to avoid or mitigate impacts to Tribal cultural resources to the satisfaction of the Tribe. The resolution also states that the Tribe will take all necessary action to oppose BOEM's actions or otherwise ensure that its invaluable cultural resources are protected if BOEM fails to act. CTCLUSI is dedicated to continuing dialogue and engage in meaningful consultation with BOEM as these projects move forward, to ensure the protection of our cultural and natural resources that could be impacted.

Currently the Coos Bay Call area reaches from Coos Bay, just north of Florence. The Department of Defense and US Coast guard have released exclusion zones, which drastically changes the Coos Bay call area. Shrinking it from 500,000 acres to approximately 180,000 acres. The next step for engagement by BOEM, will be to release the Wind Energy Areas for public review, which is expected to be released in the Spring of 2023. We will do our best to continue to keep Tribal membership informed as these projects progress. If you have any questions or comments concerning

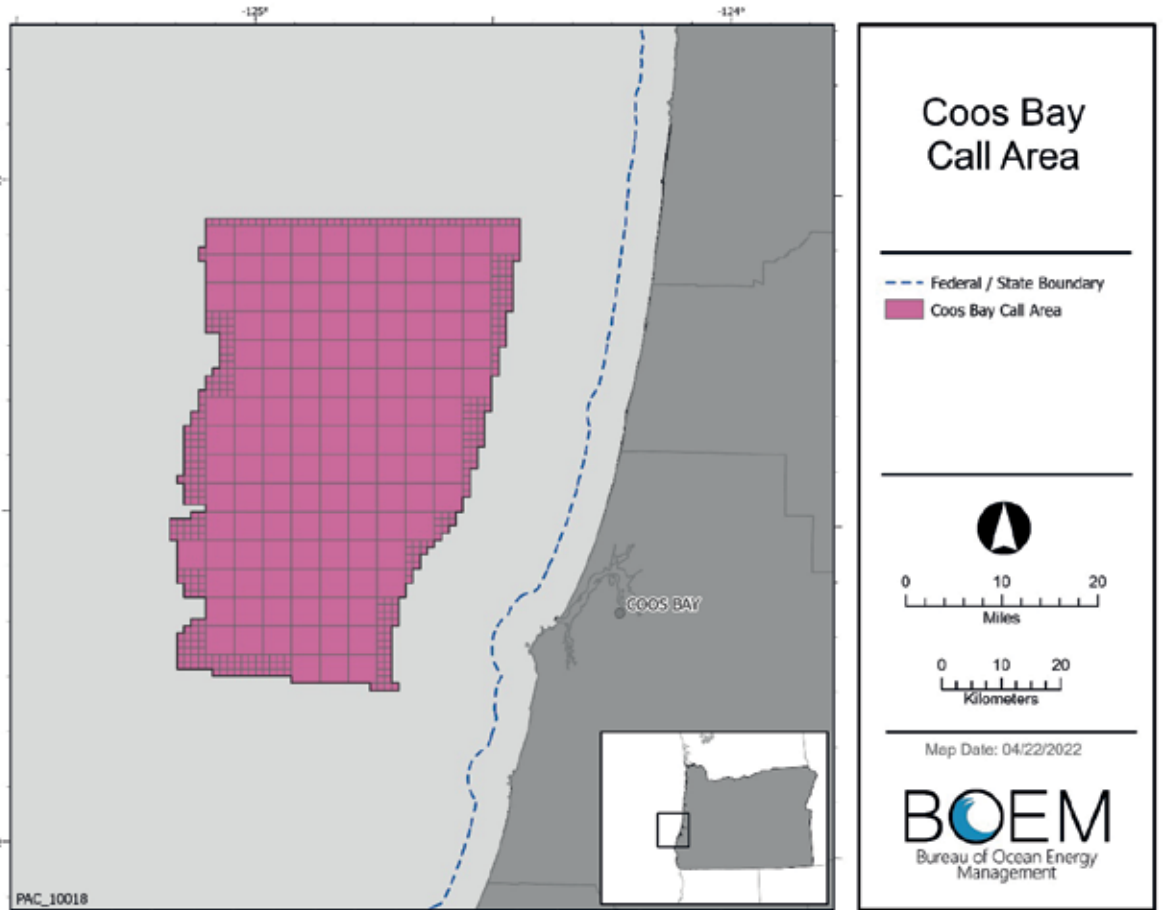


Figure 1A Call Area is a call for information and nominations from the public and developers to consider possible wind energy leasing.

CTCLUSI continues to participate in BOEM's offshore wind authorization process, which includes establishing intergovernmental task forces whose purpose is to serve as an authorizing body for issuing leases, including commercial leases, limited leases, and research leases; and reviewing plans that describe specific offshore wind project proposal. The Vice Chair Julie Siestrem is the Primary representative for the Tribe on this body with, Courtney Krossman, Tribal Historic Preservation Officer is the alternate.

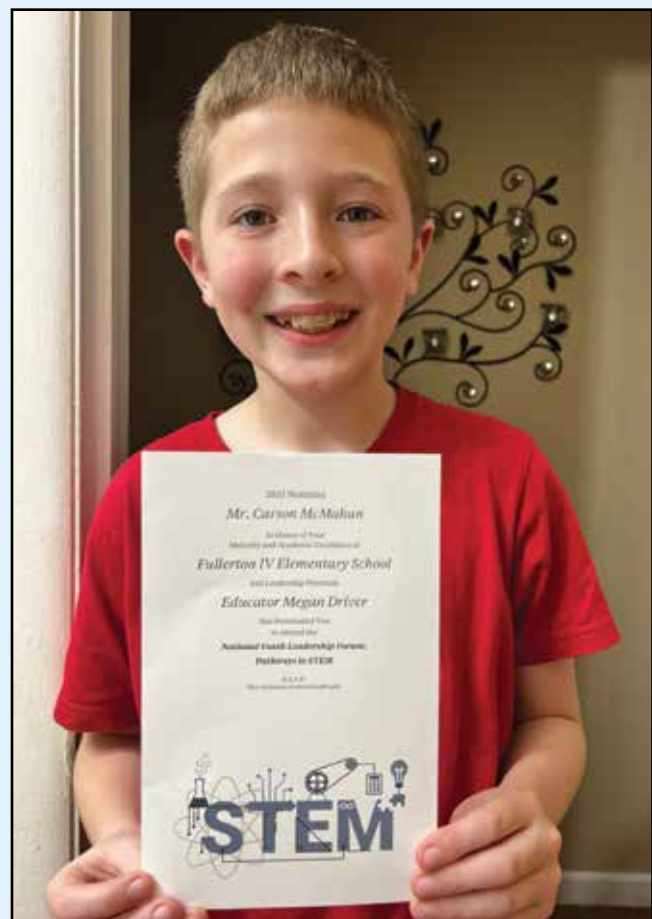

## Tribal Language Revitalization Meeting

On February 10th, the Cultural and Education Departments had a meeting with the Northwest Indigenous Languages Institute (NILI) from University of Oregon and the Oregon Department of Education (ODE).

NILI was founded in 1997 to support tribes' efforts in language revitalization. It has grown its outreach over the last 25 years and hopes to chart out a path for the next 25. They hold annual classes for community members centered around language documentation and revitalization from Tribes not only in the Pacific Northwest but around North America. They met with us to see how they can help support our programs. We took them on a tour of Cape Arago/Baldija and they provided everyone with a delicious lunch of street tacos. Over lunch we talked about the history of the Tribal Hall. In the afternoon ODE met with several tribal departments (Education, Culture, Tobacco, Drug and Alcohol Prevention) to talk about grants and programs they have for Native students at all ages.

Hosting these meetings allows us to build relationships with one another that helps facilitate long term working relationships and gives us lines of communication to other agencies to help our Tribal families.



## Language Revitalization Exhibit at Coos Historical Museum

A coalition of the Confederated Tribes Coos, Lower Umpqua and Siuslaw Indians, Coquille Indian Tribe and Confederated Tribes of Siletz worked with the Coos Historical Museum last year to create an exhibition on the Native languages of Coos County, "Reclaiming Our Words: Tribal Languages on the South Coast". The languages that are part of the

exhibition are the quiiich (Lower Umpqua) dialect of sha'yuushtt'a ut quiiich, hanis, miluk, and nuu-we-ya (Southwest Oregon Athabaskan). The exhibition opened in November and will be in the museum for about one year.

The exhibition has been visited by several groups of fourth grade students as part of learning about Native the peoples

of Coos County.

There is more Native language in another exhibit on the Museum's second floor about the history of medicine in Coos County. One section focuses on traditional Native medicines with several photos of plants and their Native names. The Tribes' Department of Natural Resources staff supplied the photos and the language.

If you have the time and opportunity to visit the museum while these exhibitions are still there, the museum is on the Coos Bay waterfront at 1210 N Front Street.

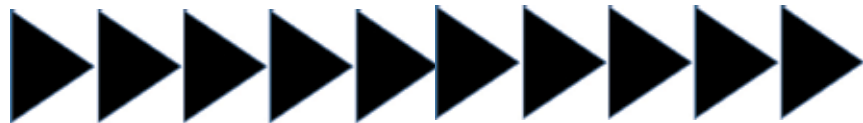

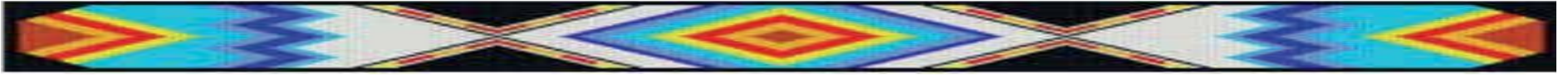

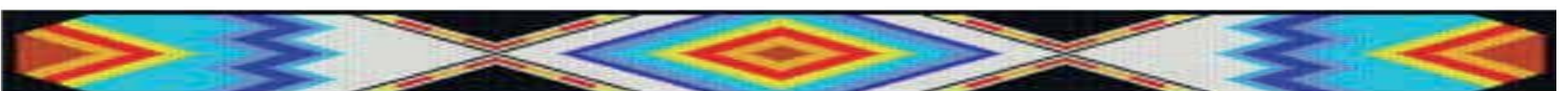

“A community foundation is a vehicle for people of all means to make a lasting difference in the community causes they care about.” [The Community Foundation (cfrrr.org).]

Tribal Elder Jeanne Schapper resides in Coburg, Oregon, a unique community with a long history of small-town spirit, generosity, and volunteerism. With that spirit of stepping up and giving back, Jeanne and four other local residents were inspired to create the Coburg Community Foundation. CCF is a nonprofit, 501(c)(3) organization whose mission is to unite and uplift the community of Coburg through philanthropy and community building.

In addition to bringing together the resources of individuals, families, and businesses within the Coburg community, CCF assists with connecting community members and organizations with outside resources such as grants to help fund projects throughout the town while encouraging stewardship of sustainable resources within the community.

Since its formation in 2019, CCF has spearheaded various projects and activities with the goal of connecting community members and building and strengthening the community. These have included supporting various events such as Coburg Days and sponsoring other events such as Dumpster Days, which promotes recycling and affords community members the opportunity to purge unused, unwanted items. Partnerships with other local organizations have been instrumental in bringing these events to the community.

During the past year, CCF was proud to launch a scholarship program made possible by donations from the community with three \$500 scholarships being awarded to deserving college-bound students. Funds were used to assist with the cost of tuition, fees, materials, and tools needed to participate in an accredited academic



or vocational/technical program. High school seniors, current college students, adults seeking training or retraining opportunities, and non-traditional students were all encouraged to apply. As part of this program, not only were scholarship recipients able to expand their educational experience, but they also provided community service hours to the Coburg Rural Fire District and to City Hall, as well as local social events, including Concerts in the Park and the Antique Fair.

The Coburg Community Foundation is looking to 2023 as “The Year of Giving Back.” The Foundation will be partnering with local organizations to sponsor several in-person community events promoting community safety and connectivity and hopes to expand this next round of local scholarships.

In the spirit of giving back, Jeanne suggests we all celebrate 2023 by volunteering, donating, connecting, and helping to build our own communities.

# March is Colorectal Cancer Awareness Month

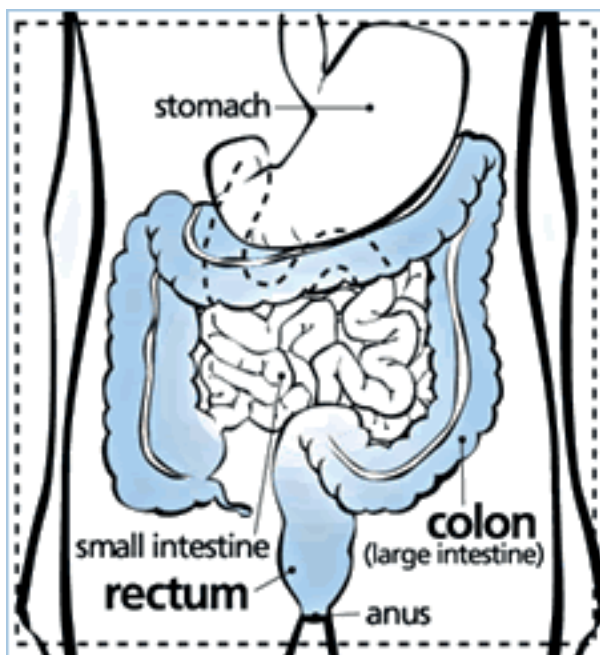

## Overview

If you're aged 45 to 75, get tested regularly for colorectal cancer. A special test (called a screening test) can help prevent colorectal cancer or find it early, when it may be easier to treat. You may need to get tested before age 45 if colorectal cancer runs in your family. Talk with your doctor and ask about your risk for colorectal cancer.

## What is colorectal cancer?

Colorectal cancer is a cancer that develops in the colon or the rectum. The colon is the longest part of the large intestine. The rectum is the bottom part of the large intestine. Like all cancers, colorectal cancer can spread to other parts of your body.



Other risk factors are:

- Having certain types of polyps (growths) inside the colon
- Having a personal or family history of colorectal cancer
- Smoking cigarettes
- Being overweight or having obesity
- Not getting enough physical activity
- Drinking too much alcohol
- Having certain health conditions, like Crohn's disease, that cause chronic (long-term) inflammation (ongoing irritation) of the small intestine and colon

## How do I decide which test to take?

There are different ways to test for colorectal cancer. Your doctor can help you decide which test you would prefer. Before you talk with your doctor about which test to get, it can be helpful to think about your values and preferences. Answer these questions to find out which test you would prefer — then share the results with your doctor. Together, you and your doctor can make a screening plan that's right for you.

## What are the different kinds of tests?

Several different kinds of tests can be used to screen for colorectal cancer. The main types are:

- Stool-based tests
- Tests that look directly inside the colon and rectum

Stool tests are done at home. You collect a stool (poop) sample and send it to a lab for testing. Then

the lab sends the results to your doctor. Tests that look directly at your colon and rectum — like a colonoscopy — happen in a doctor's office or hospital. For these tests, you need to take a laxative to clean

out your bowels before the appointment. You'll get anesthesia before the test, and you'll need someone to drive you home after the test. Your doctor will tell you how to get ready for your test, including if you need to avoid certain foods beforehand.

## Does it hurt to get a colonoscopy?

Preparing for a colonoscopy can be unpleasant, but most people agree that the benefits to their health outweigh any discomfort. And getting anesthesia means you won't have any pain or feel uncomfortable during the test.

## How often should I get screened for colorectal cancer?

How often you need to get screened will depend on:

- Your risk for colorectal cancer
- Which screening test you choose

## Take control — act early

If you start getting screened at age 45, you have a good chance of preventing colorectal cancer or finding it when it can be treated more easily.

- If your doctor finds polyps inside your colon during the test, they can remove the polyps before they turn into cancer
- If your doctor finds cancer during the test, you can take steps to get treatment right away


## Get Tested

The best way to prevent colorectal cancer — or find it early — is to get tested starting at age 45. Talk with your doctor about getting screened.

## Am I at risk for colorectal cancer?

The risk of developing colorectal cancer increases as you get older. That's why screening is recommended for everyone ages 45 to 75.
