## Important PRC Application Deadline and Limited Benefits Update

The Purchased and Referred Care department is now accepting applications for the Purchased/Referred Care (PRC) program for FY2024. You must submit a new application each year for each PRC-eligible Tribal member in your household. This year, the deadline for applications is Wednesday, January 31, 2024. Failure to submit an application for the program will result in denial of eligibility for the PRC program. If an application is received after January 31, 2024, PRC will only pay claims 90 days prior to the date the application was submitted for that calendar year. You can apply online at www.ctclusi.org. You will see a link at the bottom of the home page that will take you to the online form (or look under Member Services, Purchased and Referred Care). Please be sure to upload the front and back of your insurance card(s) to ensure we have the most current information. You must complete a separate form for each PRC-eligible family member. Please call PRC at (541) 888-4873 or (800) 227-0392 to have a hard-copy application mailed to you or with any questions.

#### **Dental Benefits**

PRC is pleased to announce that an increase has been approved for your Annual Dental Benefits. Starting January 1st, 2024 your dental benefits will increase from \$1700 to \$2500 annually. This now includes most major dental procedures including implants and orthodontia! **Orthodontia must be requested and reviewed by PRC and the CTCLUSI Dentist and will only be covered if it is deemed medically necessary.** Orthodontists must be willing to work with the PRC billing requirements. As always, cosmetic procedures are excluded, i.e. bleaching. All remaining Limited Benefits remain the same.

#### **Vision Benefits**

PRC is pleased to announce that an increase has been approved for your Annual Vision Benefits. Starting January 1st, 2024 your vision benefits will increase from \$500 to \$700 annually.

#### 2024 New Year's Day Peace Hike

Yachats, OR- On New Year's Day, the Yachats Trails Committee will host the 13th Annual Peace Hike in Yachats, Oregon. The Peace Hike traditionally honors the memory of a blind Native American (Coos) woman named Amanda who was forcibly taken away from her daughter and marched 80 miles with other captives all barefoot through the rocky terrain to the Alsea Sub-agency prison camp in what is now Yachats in 1864.

Each year, as part of the ceremony, cedar springs, a sacred tree for many tribes of the Pacific Northwest, are provided for anyone to explore prayers and set intentions with cedar. People can take the sprig and walk holding their vision of peace and its meaning.

The 2024 Peace Hike is commemorating Donald (Doc) Slyter, Chief of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians as an outstanding leader, mentor, and educator serving as a healing bridge between his Tribes and the Yachats Community.

#### Schedule

9:30AM - The Yachats Community Drum will be available, and drumming will start at the picnic shelter, located behind the Yachats Commons.

10 AM. Fire will be lit, and the ceremony will begin in part led by Tribal members including the telling of the Amanda story.

10:30 – Participants will walk with their cedar sprig on the trail they have chosen, return to the fire where they will place the Cedar sprig, to add their prayers or visions for the new year.

For those hiking to the Amanda Gathering Area, which is 2.2 miles south from the Commons, there will be several options to park to lessen that distance.

12 PM – There will be a ceremony conducted by Tribal members at the Amanda Gathering area and a fire to which to lay one's Cedar sprig.

1:00PM – There will be closing of the fires at both locations.

The Yachats Trails Committee has composed a map of alternative trails that allow everyone to hike or walk where they are most comfortable in addition to those who want to hike to the Amanda Gathering Area. Committee members will be on hand to answer questions and provide maps and guidance at the Picnic Shelter behind the Yachats Commons.

There will be two small ceremonial fires in which to place the Cedar sprigs - one near the picnic shelter and one at the Amanda Gathering Area for those who hike the Amanda Trail.

To truly understand the government sponsored genocidal policies that led to the murder and suffering of the Coos, Lower Umpqua, Siuslaw and Alsea Peoples, watch a video narrated by Patricia Whereat Phillips, Miluk Coos, member of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians (CTCLUSI) and Donald Slyter, Chief of the CTCLUSI. www.youtube.com/watch?v=N6D-wkqXGy0

## **NOTICE of SPECIAL ELECTION** February 11, 2024 **Special Election for Tribal Chief Position**

On November 4, 2023, the Tribe was notified of the passing of Chief Donald (Doc) Slyter. The Constitution of the Confederated Tribes of Coos Lower Umpgua and Siuslaw Indians requires that due to this event, the Tribal shall schedule a special election within sixty (60) days. Tribal Constitution Article XI, Section 3.

Tribal Council in compliance with Constitution and the Tribal Election Code passed Resolution 23-165 on November 11, 2023 to schedule a Special Election and call the Election Board to facilitate a Special Election to regulate election activity.

Tribal Code 7-3-41-(a) (1) states this Special Election to replace a Tribal Chief shall be subject to the remaining term of office, and this will be until April 2030.

Tribal Code 7-3-42(a) states this election shall be by secret ballot and shall be conducted in the same manner as a general election, all eligible members may vote.

Tribal Code 7-3-44 (a) (3) states that the election shall be scheduled to be held no less than ninety (90) days from the date it is called; February 11, 2023 shall be the date for the Special Election for the Tribal Chief, CLUSI Const. Art. XI Section 3.

Tribal Code 7-3-44 (b)(1) states this Special Election shall be held in conjunction with a regular monthly meeting of the Tribal Council. CLUSI Const. Art. XI Section 3.

#### Special Election Date: February 11, 2024

Candidate Eligibility: Any enrolled member of CTCLUSI, at least 21 years of age, never previously removed from office for good cause may submit a Statement of Candidacy to run for Tribal Chief.

Statement of Candidacy & Position Statement: A Statement of Candidacy form will be available on the Tribes website under "Elections" or at any Tribal Government office reception in Coos Bay, Florence or Eugene. This must be filed no later than 30 days before the scheduled election.

**Position Statement:** Any candidate can provide a Position Statement, it shall be no longer than one sheet of 8 1/2 x11 paper, two sided if desired. This is will be included in the ballot mailing, but is not required to run for this position. This can be submitted at the same time as the Statement of Candidacy.

Ballot Mailing: This Special Election will be by secret ballot by mail, sent to all current registered voters to the last known address on file in the Enrollment office, or you may vote in person and register on Election Day February 11, 2023 at the Tribal Hall located at 338 Wallace Ave Coos Bay, Oregon 97420 during the open polling hours of 12:00 p.m. and 4:00 p.m. Ballots must be mailed at least 14 days before the Election Day.

## Once thought lost for good, Native Americans' prized tobacco is back in Oregon

In a video taken at the 2023 Sacred Tobacco and **Traditional Medicine Gathering** near Bend, several members of Native American tribes or groups hold a jar containing Columbian tobacco. This strain of tobacco disappeared from the Pacific Northwest in the 1800s and was feared lost. Tribes across Oregon are reigniting their relationship with tobacco. Not just any tobacco, but the very kind their ancestors grew and used before colonization and the fur trade.

And this plant is making its comeback after being gone for nearly two centuries.

It's a sunny day at Gregory

Point on the Oregon Coast, though to the Confederated Tribes of Coos, Lower Umpgua, and Siuslaw Indians (CLUSI), this windswept place of rock, surf, and greenery is called Baldich.

Ceremonies are often held here. Tribal member Mark Petrie says one of these is the salmon ceremony, which involves remnants of a salmon feast.

"And so out here we return those salmon remains to the water, to the salmon people, respect for them and what they bring us," he

explains. "And also ask them to come back next year to feed our people and continue that longstanding relationship we've had with them for so long."

Petrie adds sacred tobacco is also offered.

Joining us is Nicole Romine, the **CLUSI Tribal Tobacco Prevention** As Program Assistant. we navigate a rocky trail with seagulls and cormorants swooping overhead, she carries a jar filled with greenish tan leaves.

"This is actually some of our first harvested tobacco," says Romine. "I was just going to do a little blessing here with you guvs and bless our stories."

I don't record the blessing, as some Native practices are to

be experienced only in the moment. But what Romine and Petrie are more than happy to share, is that this type of tobacco is called Nicotiana quadrivalis variety multivalvis, or Columbian tobacco. Back at the tribe's plankhouse in Coos Bay, Petrie says this tobacco was grown by tribal biologist John Schaefer a few years ago after a lengthy quest—a quest that began in 1825, on the banks of the Columbia River.

not praying. You're just over here using it to get that nicotine."

came into the area through Hudson Bay Company, and the ships along the coast and other sources," Kentta explains. "To me it's a little bit of a surprise that our elders picked it up that quick, because they had such strict protocols around tobacco having to be grown a certain way, and used a certain way." Those protocols eroded over generations. What was once ceremonial and practiced with care soon became a casual but addictive habit. Commerciallyprocessed tobacco products additives with became commonplace, with many appropriating Native American imagery on their labels and advertisements.

That marketing – as well as messaging that modern smoking is "traditional" - drove up commercial tobacco use, as well as health issues in Native communities. Data from The Truth Initiative shows 16% of Native American and Alaskan high-schoolers smoke cigarettes nearly three times more than non-Indians. And Native people suffer very high rates of heart disease and cancer.

"It's only to be used as a tool, to bring your prayers up to the Creator," said Scott Kalama. He's a certified prevention specialist

> at the Confederated Tribes in Warm Springs. He's worked twelve years in tobacco prevention, educating his fellow Natives on commercial tobacco versus traditional tobacco.

> "How the over-the-counter products have additives in it and how it's really addictive," he said. "I always tell them that, 'Hey man, I know you're out here, smoking a cigarette. But I know you're

"There was a man who came through, a botanist, David Douglas, looking for special plants to take back to the Royal Horticultural Society," said Petrie. "And so he heard about the sacred tobacco that the tribes were growing right next to their plank houses."

Douglas was intrigued with the Natives' sacred tobacco, but was rebuked when he asked to take some seeds back to London. So he took to more devious means.

"He came by way of night and took some seeds," continues Petrie. "(He) was caught, talked his way out of it, traded some other tobacco and I'm sure other things for the seeds. He got away with them."

Through the 19th century, traditional tobacco became increasingly rare in the Pacific Northwest. Robert Kennta, former cultural director of the Confederated Tribes of Siletz Indians, says it trended out during the fur trade.

"The traditional tobacco kinda fell out of use, once the traded tobacco

The Return

In 2006, CLUSI biologist Schaefer received one strain of important tobacco seeds Thomas from Jefferson's Monticello in Virginia. This was Nicotiana quadrivalvis variety quadrivalvis, more commonly known as Indian tobacco. But the prized Columbian tobacco seeds-the kind taken by

David Douglas-remained hard to find.

Then in 2017, there came word of a tobacco seed bank in central Europe.

At the tribal headquarters in Coos Bay, Romine leads me through a shed filled with drying plants and materials, including tule, sage, and cedar. Near the back, she presents me with a gnarled and

bulbous piece of history, Nicotiania quadrivalis variety multivalvis, the same Columbian tobacco sought for years.

"So this is the strain that made its way from the Columbia River Gorge all the way over to London, and then all the way to Pulaway, Poland," she said.

Shaking one of the plant's seed pods, Romine says Schaefer managed to have the Columbian tobacco seeds shipped from Poland that same year, ending the hunt for the tobacco planted and used by Pacific Northwest tribes.

There are more plants raised in the tribe's nearby greenhouse, not just for the Confederated Tribes of Coos, Lower Umpqua, and Siuslaw Indians, but for others.

Sharing what was once lost This past May at the Sun River Resort in central Oregon, an event called the Sacred Tobacco and Traditional Medicine Gathering held. was Petrie and others gifted the recovered Columbian Tobacco to several Native American groups and the other eight federallyrecognized tribes within Oregon's boundaries.

Petrie says it was good medicine to see tribes reconnect with the tobacco. "We have been without the sacred tobacco for so long, we have it back in our ceremonies and it brings a

Romine says this has guided her as she works in tobacco prevention efforts, and she said the plant holds a special place in her heart as she serves as its steward, currently. She also said tobacco is also offered whenever something is taken, such as during harvesting a plant or catching a fish.

"When we take something, we always give something back," said Romine. "Taking something without returning doesn't feel right for us."

As to health concerns: traditional tobacco isn't used as frequently or in the same manner as cigars, cigarettes, chewing tobacco, and vaping devices.

"You may see us wearing pouches around our necks or on our hips, on

our belts," said Petrie. "We have leather pouches, medicine bags, if you will. And we have a lot of our members that carry our secret tobacco with them in that way.

"And it is a dried form of the plant that is not necessarily dried to retain the nicotine that's in the plant, because our goal isn't to have the highest amount of nicotine in there, it's not for consumption or use in that way. We use it more for our ceremonies or dances and our gathering practices when we go out."

Petrie said the traditional tobacco was often put into clay pipes, and smoked while laying on one's back. He told KLCC at this point that this was as much as he felt comfortable sharing tribal practices with their ancestor's tobacco, given its sacred nature.

Petrie did add that care was taken not to overuse the plant, and making it a habit was not encouraged.

"It was actually noted in some of our histories that there was a term for somebody that did become addicted to tobacco, and that was a very derogatory term and it was very much frowned upon," he said. "And if any of the members did use the tobacco in a way that was more habitual, more addiction-based, they would need some help."

lot of happiness to our elders, myself, our families, that we have that back with us." he said.

The Confederated Tribes of Coos, Lower Umpgua, and Siuslaw Indians plan to have another event next year in Grand Ronde. They hope to build on the sharing of a sacred plant that was absent for nearly two centuries, and is cherished by many tribes.

Traditional tobacco versus today's commercial product?

"The traditional tobacco, was strong. It had a big kick to it," Siletz tribal member Robert Kentta says. "Because it was so strong, only older men really smoked it on a regular basis because they didn't have to get things done as much throughout the day and, and whatnot. So apparently it was strong enough that it would kind of lay you out and make you unproductive for a period of time." Commercial tobacco is raised on large plantations, and then harvested and treated with chemical additives including nicotine. Over the past century, it's not been unusual to see Native Americans and other Indigenous communities use it for blessings and ceremonies. But proponents of the traditional forms are hoping to eventually bring their ancestors' tobacco back to reclaim its use, and discontinue use of the processed variety.

"Most of my life kind of before I started my job with the tribe, my family members-many of them were smokers-chewed tobacco," said Nicole Romine. "And so I saw the harms that befell my family members, and I've lost family members through the use of commercial tobacco. Lung cancer, other cancers, other early death just caused from use of commercial tobacco and alcoholism as well. So those two things had been in my life since I was a young child."

high school and was drafted right after graduation, stage at the local community live theatre for a Veteran's serving 2 years in the United States Army. After his military service, Don met Debbie and the two were married on August 4, 1973. Don's work career included 3 -Sons Logging, mechanic at Automotive Electric, mechanic at Verger Chevrolet, and finally retiring from

Verizon Telephone in 2007 after 29<sup>1/2</sup> years.

Don was Hanis Coos, descendant of the а Family Jordan and elected Chief of the Confederated Tribes of Coos, Lower Umpqua Indians. Siuslaw and Don's commitment and participation in the Tribes spanned over five decades. His work was instrumental with the Pre-Restoration Council to help get a bill passed through Congress and signed by the President of the United States to reinstate the Confederated Tribes in 1984. 

## Wrapping up CTCLUSI's Tribal Spill Response Plan, version 2.0!

The Department of Culture and Natural south coast of Oregon. Resources (DCNR) is saying farewell to Sarah Hardisty, our Oregon Sea Grant fellow who generously gave an entire year to help the Tribe make critical updates to CTCLUSI's former Tribal Estuary Response Plan (2018), to the new and revamped Tribal Spill Response Plan.

The 2018 Plan was originally established to protect Tribal resources in the waters of Coos Bay, especially to ensure cultural resource protection in review of the Jordan Cove Liquid Natural Gas proposed project. With this Plan, the TRP staff engaged in planning conversations with agencies and partners in response and resource protection, such as EPA, the USCG, ODEQ, and other emergency management professionals. CTCLUSI also became the third Tribe to become a member of the EPA **Region 10 Regional Response** 

Team (RRT) and the Northwest Area Committee (NWAC), alongside the Makah Indian Tribe and the Confederated Tribes and Bands of the Yakama Nation.

Since 2018, CTCLUSI has undergone significant growth. The Tribe has gained an additional 15,000 acres in forest lands, purchased additional properties, implemented both a dental and health clinic, established an Emergency Operations Center and Emergency Manager, just to name some examples. TRP staff have also made significant strides in building capacity for spill response and contamination investigation since 2018. EPA has begun funding additional staff in water quality and tribal response as well as spill response equipment and supplies. Staff have assisted in reviewing response plans and regulation changes from other agencies and incorporating Tribal language and interests, updating the regional geographic response strategies with ODEQ and the USCG, and helped update CTCLUSI's Area of Interest geographical boundary. Staff have also worked to build the most comprehensive environmental testing laboratory on the

With these changes, TRP staff realized that the plan needed to be updated for not just new capacity and policy, but also to include an updated Tribal Area of Interest and jurisdictional properties. This draft is in its final stages for a solid first draft. An early draft was presented to Tribal Council



for review and initial feedback. Following that, staff are finalizing contributions and changes by this month. This first draft will be submitted to the Regional Response Team (including EPA, USCG, and ODEQ) for feedback. Changes stemming from these comments will be presented to Council again in 2024 for feedback, and hopefully closing for a final draft in that year with Tribal Council's resolution.

We sincerely thank Sarah not just for her substantial work on all of this, but for her kind and generous energy during her time with our team. She will be joining us for one last outreach event at CTCLUSI's holiday party on December 9th, where the community will get to meet her in person and see the results of her hard work.

A note from Sarah:

Looking back at this past year, I have gained so much from my fellowship with the Confederated Tribes of Coos, Lower Umpqua, and Siuslaw Indians beyond the knowledge of Oil Spill Response protocol and policy. The values of CTCLUSI are reflected in the spill response plan, and the effort to protect the natural resources and

culture of the land is apparent in DCNR. We have worked towards expanding the spill response plan to protect oceans and inland areas stretching across CTCLUSI's over 3 million acres of culturally relevant land and to improve communication between state agencies and CTCLUSI.

I am grateful to have worked with our

partners and those at CTLCUSI who have participated in the project! My primary background is in science – my graduate school project was on the bay ghost shrimp - but have had some coursework and an internship in science policy. Through this fellowship, I have been able to engage in Northwest Committee/Regional Area Response Team Meetings which include members from the Makah and Yakama Nation, EPA, Coast Guard, ODEQ, and WDOE. I also was able to attend the West Coast Ocean Alliance meeting which included 20 tribal government members and was facilitated in

part by Margaret Corvi, who originally wrote the Oil Spill Estuary Response Plan and is the Tribal Coordinator for WCOA. These were important opportunities to see how different government entities work together and listen to Tribal government priorities. Updates from me, and other Sea Grant fellows, can be found on the blog: Sea Grant Scholars | Learning through experience, for the future of our oceans.

There can be a lot of doom and gloom in oil spill response - it is not fun to think about the effects of oil or hazardous chemicals affecting wildlife or the lack of communication or compensation for Tribal Governments in the event of the spill. However, working towards preventing these from occurring is meaningful and rewarding. A book that I would recommend to pick up this winter is Climate Optimism by Zahra Biabani that highlights climate 'wins' internationally. It highlights when oil companies have been held accountable for spills or to cut emissions, and when pipelines or offshore oil and gas leases were halted. It also covers topics like information overload and negativity bias in the news.










### **CTCLUSI** Dental Team Expands

## Tribal Member Stephanie Fong Honored by Staff on National Boss's Day









## Hiis Haiyach - with a good heart


## Cedar Deer


Soak all of the cedar pieces in warm water for approximately 2 hours or until bendable. Keep them damp as you weave. (A spray or mist bottle works best.) Follow illustrations A through M, making sure to weave tightly.



To finish the cedar deer, refer to Illustration N. Bend cedar piece #1 behind #3. Cut off excess cedar, leaving a long enough piece to tuck under a weaver in back. Bend cedar piece #2 behind #1. Cut off excess cedar, leaving a long enough piece to tuck under a weaver in back. Bend cedar piece #3 behind. Cut off excess cedar, leaving a long enough piece to tuck under #2 weaver in back. Cut the 4 deer legs to ~ 3 inches from the body. Cut at an angle for tail, about 1 inch from the body. Cut the 2 ears to a point, 3/4 inch from head. See photo. Note: variations in cutting tail, legs, and ears or antlers creates a doe or stag. Be creative!

Trim and cut antlers, hooves, and tail. For antlers, cut them vertically part way down the center ,and then while wet, curl them over a pencil. Some like to cut them vertically in half part way and then fold each down at different lengths. Decorate with ribbon if desired. For hanger, slip a thin ribbon through one of the
