

25th Anniversary of Elders Honor Day

Florence, Ore. – The Confederated Tribes of Coos, Lower Umpqua & Siuslaw Indians co-hosted with The Coquille Indian Tribe the 25th Anniversary of Elders Honor Day. This year's event was held at the Three Rivers Casino Resort in Florence, Oregon on Friday, March 15th and Saturday, March 16th

Doors to the Three Rivers Casino Event Center opened at 10:00 a.m. for Tribal Elders from around Oregon to gather and visit after check in. Upon arrival they were greeted with smiles from CTCLUSI and Coquille Staff, signed in, received their event program booklet, signed up to be named King or Queen for the day, and received their free commemorative 25th Anniversary t-shirt designed by Quuiich (Lower Umpqua) tribal member Morgan Gaines for the CTCLUSI Elders Committee.

Once they found a table to gather around, the Elders seated themselves and were graced with more gifts. At each place setting, a gift of dried cranberries, canned

smoked salmon, and a gift bag awaited them. The most special gift awaiting them was the beaded headdress ornament made by Quuiich (Lower Umpqua) Tribal Elders Sue Olson who walked on in July of 2022. Sue was a beloved Elder of CTCLUSI and a tremendous traditional arts and beadwork knowledge holder. She created gifts for the Elders each year and we are eternally grateful for her presence that evening through the spirit of her gift giving.

At 11:00 a.m. CTCLUSI Chief Doug Barrett gave an opening invocation and welcomed the Elders to the 25th Annual Elders Honor Day event co-hosted by CTCLUSI and Coquille Tribes. He then asked for attendees to stand and remove their caps for the presentation of the flags.

Coquille Tribal member Ann Niblett welcomed the Color Guard with a song and hand drumming. The Eagle Staff led the Nation Flags in held proudly by our Tribal Veterans, where they were presented on stage for the duration of the event.

Tribal Chairman Brad Kneaper of CTCLUSI then came to the stage and gave an opening welcome. He also gave introductions of the current Tribal Council members of the hosting Tribes in attendance, he asked them to stand to be recognized. He also recognized the members of the various Elders committees in attendance as well as all the Veterans in the room. After these special recognitions the event continued with honoring the Eldest Man and Woman present. Veteran Edmund Ben from the Siletz Tribe and Maxine Marlow of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians were showered with gifts from the two hosting Tribes as well as Pendleton blankets. Following the Eldest guest acknowledgements was the drawing for the King and Queen. Tribal Elders had the option to put their name in for a raffle of King and Queen for the day and two lucky winners were honored throughout the day.

Grand Ronde Tribal Elder Phyllis Brown was picked for Queen and CTCLUSI Tribal



Greetings everyone,

I hope that this finds you all well.

In light of the recent letter sent to the Tribal Community about the new pharmacy, I have asked Deputy Health Director Iliana Montiel to give some information to all of you through this article. I am excited to see this information come forth. Along with potentially tremendous saving to you, it is also an opportunity to expand some health benefits outside our Five County Service Area. I hope that in time we can expand other services outside as well. That is a goal that we have that I feel is very important to all our tribal families, no matter where you live. Below is the information that Iliana forwarded to me, and I am forwarding through this article.

Three Rivers Pharmacy mail order service is now fully operating. In March it was open to all tribal members. Starting April 1st, it will be open to tribal families and employees of CTCLUSI and TRC. See

the flyer in the newsletter on how to transfer. You are not required to use the QR code for your transfers and may call for assistance. Please call 866-468-4679 and press 1 to be transferred to Three Rivers Pharmacy. If you do not end up at Three Rivers Pharmacy, just ask for Dara or Hero and you will be redirected to our specialists. If you are receiving too many marketing emails, you may opt-out. At the bottom of the email you can "unsubscribe". This will not affect personal emails to you regarding your specific prescription. If you receive a controlled substance, those meds will not be part of the mail-order, until the Pharmacy opens at Three Rivers Health You will continue to use your local pharmacy for those medications. Please remember to transfer your medications (other than controlled substances) by June 1st.

TITLE: 10 - NATURAL RESOURCES AND THE ENVIORNMENT

Chapter 10-2 TRIBAL FOREST RESOURCES MANAGEMENT CODE

The Tribal Council has approved the draft language to establish Chapter 10-2 Tribal Forest Resources Code for First Reading; and

CLUSITC Chapter 10-2, In accordance with the foregoing Tribal and Federal authorities and the Tribe's retention of the full spectrum of sovereign powers, the Tribal Council has the authority, desires to and does hereby establish this Tribal Forest Resources Management Code for the following purpose:

- To establish formal Tribal government direction, standards and procedures for management of Tribal trust forest lands;
- (2) To strengthen Tribal sovereignty and advance the principles of self-governance in carrying out forest management activities; and
- (3) To fully exercise Tribal authority in carrying out forest management activities as authorized by Tribal law and provided for in the Indian Trust Asset Reform Act ("ITARA") (P.L. 114-178), the NIFRMA, the Indian Self-Determination and Education Assistance Act ("ISDEA") (P.L. 93-638) and other applicable Federal law

Tribal Council hereby approves the establishment of Chapter 10-2 Tribal Forest Resources Management Code and hereby approves for first reading draft be posting for a twenty-eight (28) day period. Draft language as set out in the attached **Exhibit A** (deleted text is red and stricken and new text is blue and underlined),.

Seeds of Success Community Fellows Field School Internship

July 8th - 19th, 2024

Contributed by the Culture & Natural Resources Department

Community Fellows interns will learn and implement a two-eyed seeing approach to create forests more resilient to climate change and learn how Indigenous Knowledge can help inform conservation and management on the CTCLUSI forest lands. Interns will work in the woods, collect seeds of native plants, and learn about ethnobotany, soil science, pollinator ecology, wildlife, forestry and ecocultural restoration while gaining employment skills in the outdoors.

During the 8-hour daytime sessions interns will be trained by CTCLUSI leaders and Oregon State University graduate students, collect data using science protocols and tools, and learn about forest ecology.

In the evenings there will be group activities such as traditional crafting using indigenous materials, storytelling, and games. Interns will camp during the work week, with the weekend off to go home. All meals will be nutritious and delicious, and private shower and bathroom facilities will be at the campsite.

Internship participants will work alongside OSU College of Forestry faculty and researchers as well as CTCLUSI Natural Resources and Forestry staff, performing research related to the restoration of culturally important plants on the Tribes' Lake Tract. Meals, transportation, and all work supplies will be provided. This will be an immersive experience, with participants camping at the Tribes' Deadwood Property. A stipend will also be paid to participants after program completion.

Community Fellows intern requirements and expectations:

- Ages 14 19
- Tribal family member or has a relationship with CTCLUSI
- Must remain on site with the group 24 hours per day during the week.
- Cooperate as a respectful team member and ask for help as needed.
- Must have the ability to walk long distances on brushy, uneven terrain.

Elder Frank Brainard was selected as Rivers Casino as a thank you for her years and the Coquille Tribe staff for their work King. They were called up to the stage to be "crowned" King and Queen with cedar bark headpieces, wrapped in a Pendleton blanket, and gifted a basket from each of the hosting Tribes. The baskets were filled with items like a painted hand drum, beautiful dentalium and scallop shell necklaces, assorted treats, hand painted dance paddles and more.

A special honoring was then announced by Chair Kneaper and Iliana Montiel, Assistant Director of Health Services. Montiel ran the Elders program for CTCLUSI for the last 13 years, this year being her last running the Elders Program and Elders Honor Day event she shared, "It is my great pleasure to introduce our founders of this wonderful program. Jane Metcalf from the Coquille Indian Tribe & Arleen Perkins from CTCLUSI"..."I believe the Coquille Tribe started the tradition a few years before CTCLUSI did. CTCLUSI did not have a casino yet, so they hosted at various places in the beginning like the Armory and our Tribal Hall. When the coordinators of both Tribes were applying for grant funds through Title VI, they combined our Tribes in order to have enough Elders to be eligible. After that they decided to Co-host Elders Honor Day and share being hosting tribe every other year between The Mill Casino & Three Rivers Casino Resort. The tradition has followed for 25 years." The two special honorees were brought to the stage and wrapped in Pendleton blankets.

Staff from CTCLUSI then surprised Iliana Montiel with a gift donated by the Three

During a brief break, the room was reset for the evening meal. Elders were welcomed back into the room at 5:00 p.m. and greeted by staff and Coquille Tribal Chair Brenda Mead. Gift bags from the Coquille Tribe were placed and each table for every Elder to take home. These gifts were filled with canned smoked salmon, smudge sticks, huckleberry jam, and more.

Chair Meade again shared her thanks to Elders Arleen Perkins and Jane Metcalf for getting this wonderful co-host event started. She also thanked Lori Austen

in helping put together this event. Chair Meade also welcomed Coquille Tribal Chief Jason Younker to the stage to give the evening invocation.

Dinner was served buffet style and consisted of salmon and pot roast with all the sides. Elders enjoyed their evening meal and visiting, making sure to make their way to all the venders in the room and get their last-minute raffle tickets for the evening drawing for prizes. Raffle tickets were sold throughout the day for \$1 a piece or 6 for \$5. The profits from raffles sales goes back into the Elders program to help fund the Elders Scholarship for Tribal students. 

National Nutrition Month

National Nutrition Month is an annual campaign established in 1973 by the Academy of Nutrition and Dietetics. Everyone is invited to learn about making informed food choices, developing healthy eating, and physical activity habits.

This year's theme is "Beyond the Table," which addresses the farm-to-fork aspect of nutrition, from food production and distribution, to navigating grocery stores and farmers markets — and even home food safety and storage practices.

Eat Right

Food, Nutrition and Health Tips from the Academy of Nutrition and Dietetics - 20 Health Tips;

1. Eat Breakfast

Start your day with a healthy breakfast that includes lean protein, whole grains, fruits and vegetables. Try making a breakfast burrito with scrambled eggs, low-fat cheese, salsa and a whole wheat tortilla or a parfait with low-fat plain yogurt, fruit and whole grain cereal.

2. Make Half Your Plate Fruits and Vegetables

Fruits and veggies add color, flavor and texture plus vitamins, minerals and dietary fiber to your plate. Make 2 cups of fruit and 2 ½ cups of vegetables your daily goal. Experiment with different types, including fresh, frozen and canned.

3. Watch Portion Sizes

Use half your plate for fruits and vegetables and the other half for grains and lean protein foods. Complete the meal with a serving of fat-free or low-fat milk or yogurt. Measuring cups may also help you compare your portions to the recommended serving size.

4. Be Active

Regular physical activity has many health benefits. Start by doing what exercise you can. Children and teens should get 60 or more minutes of physical activity per day, and adults at least two hours and 30 minutes per week. You don't have to hit the gym – take a walk after dinner or put on music and dance at home.

5. Get to Know Food Labels

Reading the Nutrition Facts panel can help you choose foods and drinks to meet your nutrient needs.

6. Fix Healthy Snacks

Healthy snacks can sustain your energy levels between meals, especially when they include a combination of foods. Choose from two or more of the MyPlate food groups: grains, fruits, vegetables, dairy, and protein. Try raw veggies with low-fat cottage cheese or hummus, or a tablespoon of nut or seed butter with an apple or banana.

7. Consult an RDN

Whether you want to lose weight, lower your health-risks or manage a chronic disease, consult the experts! Registered Dietitian Nutritionists can help you by providing sound, easy-tofollow personalized nutrition advice.

8. Follow Food Safety Guidelines

Reduce your chances of getting sick with proper food safety. This includes: regular hand washing, separating raw foods from ready-to-eat foods, cooking foods to the appropriate internal temperature, and refrigerating food promptly. Learn more about home food safety at eatright.org.

9. Drink More Water

Quench your thirst with water instead of drinks with added sugars. Stay hydrated and drink plenty of water, especially if you are active, an older adult or live or work in hot conditions.

10. Get Cooking

Preparing foods at home can be healthy, rewarding and costeffective. Master some kitchen basics, like dicing onions or cooking dried beans.

11. Order Out without Ditching Goals

You can eat out and stick to your healthy eating plan! The key is to plan ahead, ask questions and choose foods carefully. Compare nutrition information, if available, and look for healthier options that are grilled, baked, broiled or steamed.

12. Enact Family Meal Time

Plan to eat as a family at least a few times each week. Set a regular mealtime. Turn off the TV, phones and other electronic devices to encourage mealtime talk. Get kids involved in meal planning and cooking. Use this time to teach them about good nutrition.

13. Banish Brown Bag Boredom

Whether it's for work or school, prevent brown bag boredom with easy-to-make, healthy lunch ideas. Try a whole-wheat pita

pocket with veggies and hummus, or a low sodium vegetable soup with whole grain crackers, or a salad of mixed greens with low-fat dressing and a hardboiled egg.

14. Reduce Added Sugars

Foods and drinks with added sugars can contribute empty calories and little or no nutrition. Review the new and improved Nutrition Facts Label or ingredients list to identify sources of added sugars.

15. Eat Seafood Twice a Week

Seafood – fish and shellfish – contains a range of nutrients including healthy omega-3 fats. Salmon, trout, oysters and sardines are higher in omega-3s and lower in mercury.

16. Explore New Foods and Flavors

Add more nutrition and eating pleasure by expanding your range of food choices. When shopping, make a point of selecting a fruit, vegetable or whole grain that's new to you or your family.

17. Experiment with Plant-Based Meals

Expand variety in your menus with budget friendly meatless meals. Many recipes that use meat and poultry can be made without. Vegetables, beans, and lentils are all great substitutes. Try including one meatless meal per week to start.

18. Make an Effort to Reduce Food Waste

Check out what foods you have on hand before stocking up at the grocery store. Plan meals based on leftovers and only buy perishable foods you will use or freeze within a couple of days. Managing these food resources at home can help save nutrients and money.


19. Slow Down at Mealtime

Instead of eating on the run, try sitting down and focusing on the food you're about to eat. Dedicating time to enjoy the taste and textures of foods can have a positive effect on your food intake.

20. Supplement with Caution

Choose foods first for your nutrition needs. A dietary supplement may be necessary when nutrient requirements can't be met or there is a confirmed deficiency. If you're considering a vitamin, mineral or herbal supplement, be sure to discuss safe and appropriate options with an RDN or another healthcare provider before taking.

Tribal Police Department to Participate in DEA National Prescription Take Back

The Tribal Police Department will once again be participating in the National Prescription Drug Take Back Day held on Saturday April 27th from 10am – 2pm at the governmental offices at 1245 Fulton Avenue in Coos Bay. This event is sponsored by the Drug Enforcement Administration (DEA) and it provides the supplies to be able to collect unused or expired prescription medications to ensure that they are safely disposed of without falling into the wrong hands or unnecessarily polluting.

TPD personnel will be outside (parking lot) so that participants can just pull up and drop off their items.

After the event (on Saturday), from 2pm – 3pm, Tribal Police Officers will be available to travel within 20 miles of the governmental office to pick up any unused or expired medications from Tribal families or Tribal Elders. If you know of someone who would like to participate, but is unable to make it to any of the events, please have them contact me for scheduling at our office: 541-997-6011.

There will be no identifying information collected, and the program is anonymous. We encourage participants to remove any identifying labels from bottles prior to submission. We will be able to accept vape pens without internal batteries, controlled, non-controlled and over the counter medications with a few exceptions; Intra-venous solutions, injectables, syringes, chemotherapy medications, or medical waste WILL NOT be

accepted.

If you have any questions about the program, please let me know. Our goal is to keep medications from being lost, stolen, or misused. If you would like to view information about the program from the DEA, please visit: https://takebackday.dea.gov/. If you know someone who lives outside of the area, they can also search by zip code to find an event nearby.

In addition to the National Drug Take Back Day on Saturday, Tribal Police Officers will be at the Eugene outreach office on Thursday, April 25th from 11am - 2pm to accept any medications and also at the Florence outreach office on Friday, April 26th from 11am - 2pm.

Since we began partnering with the DEA in the NDTBD program in 2018, the Tribal Police Department has helped to keep over 319 pounds of medications from being misused or otherwise polluting our landfills and waterways. Anyone is welcome to participate, so feel free to share the information with your friends and family.

Tribal PD and Social Services Build Relations with Springfield PD



I'm grateful to be a part of the ĆTCLUSI team and look forward to meeting and learning from people as much as I can.




